The Texas Higher Education Coordinating Board (THECB) is required to invite all eligible institutions the opportunity to participate in these programs in order to be included in the allocation calculation process on an annual basis. General rules concerning the invitation are found in <u>Chapter 4, Chapter 21</u> and <u>Chapter 22</u> of the Texas Administrative Code under the **Allocations** section for each applicable program.

All institutions are required to complete the enclosed Opt-In/Opt-Out form. Participation in the listed state financial aid programs are contingent upon completing the survey and institutions who do not submit an Opt-In/Opt-Out form by the deadline will not be included in the allocation calculation process for the 2020 Fiscal Year. Institutions that completed a form were sent a copy of the selections made through a confirmation email to the submitter.
