<u>STATUTE</u>

TEXAS Grant §56.307

(e) The coordinating board may adopt rules that allow the coordinating board to increase or decrease, in proportion to the number of semester credit hours in which a student is enrolled, the amount of a TEXAS grant award under this section to a student who is enrolled in a number of semester credit hours in excess of or below the number of semester credit hours described in Section 56.304(a)(5) or 56.305(a)(3).

TEOG §56.407

(b) The coordinating board may adopt rules that allow the coordinating board to increase or decrease, in proportion to the number of semester credit hours in which a student is enrolled, the amount of a grant award under this section to a student who is enrolled in a number of semester credit hours in excess of or below the number of semester credit hours described in Section 56.404(a)(4) or 56.405(a)(3).

TEG §61.229

(a) The coordinating board may make reasonable regulations, consistent with the purposes and policies of this subchapter, to enforce the requirements, conditions, and limitations expressed in this subchapter.

(e) Prorated Awards. If the student's balance of eligible hours is less than the number of hours he or she is taking in a given term or semester, the student's award amount for that term or semester should be prorated using the following schedule:

(1) If balance of hours = 12 or more hours - 100% of the maximum award;

(2) If balance of hours = 9-11 hours - 100% of the maximum award;

(3) If balance of hours = 6-8 hours - 50% of the maximum award; and

(4) If balance of hours = fewer than 6 hours and student is enrolled for at least 6 hours - 25% of the maximum award.

(f) Prorated Awards, beginning with Awards for the 2015-2016 Academic Year. If the student's balance of eligible attempted hours is less than the number of hours he or she is taking in a given term or semester, the student's award amount for that term or semester should be prorated. Beginning no later than Fiscal Year 2012, prorated amounts shall be calculated using the following schedule:

(1) If balance of attempted hours = 12 or more hours - 100% of the maximum award;

(2) If balance of attempted hours = 9-11 hours - 100% of the maximum award;

(3) If balance of attempted hours = 6-8 hours - 50% of the maximum award; and

(4) If balance of attempted hours = fewer than 6 hours and student is enrolled for at least 6 hours - 25% of the maximum award.

TEOG § 22.260

(b)(3) Beginning with awards for fall 2014, the value of an individual's award in a given term is to be based on the share of a full-time course load in which the student is enrolled as of the census date of the term, in accordance with the following table:

(A) 12 or more semester credit hours = 100% of the semester's maximum award for a full-time student;

(B) 9 to <12 semester credit hours = 75 percent of the semester's maximum award for a full-time student;

(C) 6 to <9 semester credit hours = 50 percent of the semester's maximum award for a full-time student; and

(D) <6 semester credit hours = 0, unless granted an award under hardship conditions in accordance with paragraph (2) of this subsection.

(e) Prorated Awards in Case of Low Balance of Eligible Hours or Attempted Hours. If the student's balance of eligible hours or attempted hours is less than the number of hours he or she is taking in a given term or semester, the student's award amount for that term or semester should be prorated using the following schedule:

(1) If balance of hours equals 12 or more hours--100% of the maximum award;

(2) If balance of hours equals 9-11 hours--75% of the maximum award;

(3) If balance of hours equals 6-8 hours--50% of the maximum award; and

(4) If balance of hours equals fewer than 6 hours--25% of the maximum award.

(g) Prorated Awards.

(1) Awards to undergraduate students enrolling in fewer than the required number of hours in a given semester due to fewer hours needed for graduation shall be prorated based on the following schedule:

(A) If enrolled for the equivalent of 9 or more hours in a regular semester or 75% or more of the normal full-time enrollment of the undergraduate student's program of study--100% of the maximum award;

(B) If enrolled for the equivalent of 6-8 hours in a regular semester--50% of the maximum award; and

(C) If enrolled for the equivalent of fewer than 6 hours in a regular semester--25% of the maximum award.

(2) Awards to graduate students enrolling in fewer than the required number of hours in a given semester due to fewer hours needed for graduation shall be prorated based on the following schedule:

(A) If enrolled for the equivalent of 7 or more hours in a regular semester or 75% or more of the normal full-time enrollment of the graduate student's program of study--100% of the maximum award;

(B) If enrolled for the equivalent of 5-6 hours in a regular semester or 50 percent of the normal full-time enrollment of the student's program of study--50% of the maximum award; and

(C) If enrolled for fewer than 5 hours in a regular semester or less than 50 percent of the normal full-time enrollment of the student's program of study--25% of the maximum award.

(3) At institutions with regular semesters, awards to a 2006 Revised TEG Program student who is enrolled for a limited number of hours due to a hardship as referred to in §22.24(e) of this title (relating to Provisions that Apply Only to 2006 Revised TEG Program Students) shall be made on a pro rata basis of a full-time award in keeping with subsection (g) of this section.
