The aim of the 60x30TX higher education strategic plan is to help all students achieve their educational goals, which, in turn, will help Texas remain globally competitive for years to come. 60x30TX is entirely student-centered: Its overarching goal is that 60 percent of young adults (ages 25-34) in Texas will hold some type of postsecondary credential by 2030. Other goals are that by 2030, more students (regardless of age) will complete a certificate or degree; graduates will have identifiable marketable skills irrespective of major; and that, statewide, students will not graduate with debt exceeding 60 percent of their first-year wages. Successful achievement of these four, interrelated goals will require unprecedented collaboration among K-12, higher education, and the workforce, as well as the local creativity of Texas two- and four-year colleges and universities. Higher Education Commissioner Harrison Keller will provide an overview of the state of higher education in Texas, a brief overview of 60x30TX, and the progress being made with respect to achieving the plan's goals and targets.

The system has been in place for nearly 15 years and is used to track performance on critical measures that exemplify the missions of Texas higher education institutions. Deputy Commissioner David W. Gardner and Assistant Commissioner Julie A. Eklund will provide an overview of 60x30TX.com, the Accountability System, and the accountability data that can be used by higher education leaders to assist them in advancing their institutional missions and moving Texas forward in accomplishing the state's higher education goals. They also will provide an overview of the THECB's work to date with regions and institutions with respect to "regional targets and strategies" in three areas of 60x30TX – the Educated Population goal, the Completion goal, and the High School-to-College Direct Enrollment target.

prevent further mass shootings by enhancing reporting requirements and ensuring law enforcement and the
public have the training, tools, and resources they need to provide and respond to Suspicious Activity Reports.
The action by the governor is a starting point in the process to keep Texas communities safe. Mr. Avant will
discuss Executive Order #5; that is, how the Department of Public Safety will work with the Texas Education
Agency and the Texas Higher Education Coordinating Board on ways to better inform schools, students, staff,
and families about the importance of Suspicious Activity Reports and how to initiate that process.

The high-impact practices at these colleges produce graduates that are motivated to transition to workforce, and that leave their institutions with the genuine belief higher education was well worth the money and time spent. Senior Director Ginger L. Gossman will facilitate a panel discussion of practices public higher education institutions can model after private liberal arts colleges to implement the marketable skills goal.		The avenues through which students are exposed to marketable skills will vary by institution and program, as will the avenues through which these skills are communicated to students. 60x30TX provides latitude for two- and four-year institutions and encourages local creativity in pursuing the goals as institutions pursue their own distinct missions. Providing unique paths for learning and communicating skills is part of these unique missions. Deputy Commissioner David W.
