## TASFA File Layout Overview


All institutions participating in state financial aid programs **must** accept the data generated by the completion of an online TASFA. Institutions may accept the paper TASFA from applicants who do not have access to the necessary technology to complete the online TASFA. Please note that institutions can require an applicant to submit additional information to accompany the data received on the TASFA (see <u>Texas Administrative Code</u>, <u>Section 22.6</u>).


#### TASFA Data Collection

To collect the data for the online TASFA, an applicant will create their account through a dedicated <u>TASFA landing page</u> which will be linked through ApplyTexas and College For All Texans website. Once they log into their account and access the main **Application** page, the applicant will enter data in the following sections.

#### Additional Information:

- The data collected on the TASFA will not be validated by the Texas Higher Education Coordinating Board (THECB) against external databases (i.e., IRS, selective service, etc.).
- An applicant can select up to 10 colleges for their initial submission.
- Once submitted, the application is locked, and corrections cannot be made.
- If the applicant identifies a mistake after submission, the institution will collect documentation from the student directly to confirm necessary corrections.
- Applicants will not have the ability to upload or submit documentation using the online TASFA. They will need to send corresponding paperwork to the institutions directly.
- After the initial submission, an applicant can log in to send their TASFA to more colleges, up to 10 per session.
- An applicant will be able to download or print their submitted application for each college.
- Each institution will use the data provided by the THECB to calculate the Student Aid Index (SAI).
- The THECB will only send applications to the institution that have been submitted; partially completed applications will not be provided.



#### **TASFA Submission Flow**



## **Data File Processing**

TASFA files will be sent to institutions through a secure file transfer protocol (SFTP) using the THECB's online portal, <u>MOVEit DMZ</u>. Each institution will have a dedicated **TASFA\_Output** folder.



Files will be uploaded into TASFA\_Output folder under the applicable award year using a batch process by the THECB.



#### Files Uploaded to MOVEit

TASFA Output files containing TASFA submissions for that specific date will be provided in both fixed-length and CSV format. In addition, a daily cumulative report will be uploaded in CSV format for institutions to track all TASFA submissions to date.

#### TASFA Output File (Fixed-Length)

The TASFA data file will be sent to institutions in a **Fixed-Length** (also known as Fixed-Width) text format which displays characters in one continuous string of data.

#### Fixed file naming convention in MOVEit:

#### TASFA Output File (CSV)

A TASFA data file will also be provided in a CSV format in addition to the fixed-length text file. This file will have column headings in the spreadsheet to assist institutions to align data in each column with each TASFA question.

#### CSV file naming convention in MOVEit:

Below are the alignment standards for the position types found in both the fixed-length and csv files:

- Numeric Positions are right justified.
  - If the total positions are not needed for the numeric entry, leading zeros will be included in the file.

#### Example:

- Field allows 9 numbers to be entered
- Amount entered by user: \$1,000
- File will include: 000001000
- o Alphanumeric Positions are left justified.
- Blank Positions are left justified.
  - If a field is skipped because it is **Optional** or conditional, blank spaces will be included in the file to account for the applicable positions.

#### Daily Report: CSV

A cumulative CSV file will be uploaded into MOVEit daily and will include only the applicants that have submitted a TASFA for the applicable award year for the specific institution.

#### Daily report CSV format details:

Report will be displayed chronologically from newest to oldest in the institution's folder by award year and will include:

- Award year (2024-2025)
- o Student's First Name
- o Student's Last Name
- Student's Email Address
- Student's Application ID#
- o Student's Date of Birth
- o Acknowledgement Date
- o Submission Date
