RE: 2017-18 Educational Aide Exemption (EAE) Final Allocation Amount

This memo is to announce the enclosed final allocation amount for the EAE program for the 2017-18 academic year.

On May 16, 2017, preliminary allocation figures for the EAE program were issued to institutions. Institutions were invited to confirm that the preliminary allocation spreadsheet accurately reflected the data submitted to the Texas Higher Education Coordinating Board (THECB). Institutions were allowed 10 days to review the data. That period ended at the close of business on May 30, 2017.

Through this process, THECB received comments about the data and adjustments to the allocation calculations have been made to reflect those comments. Institutions participating in the EAE program are required to utilize institutional matching funds to cover at least 10% of each recipient's exemption. Disbursements for EAE funds will be issued the first week after the first day of the new fiscal year, September 1, 2017.
