RE: Financial Aid Database (FAD) Report FY 2018

The FAD Manual for the 2017-18 (FY 2018) year is now available. Beginning 2018, institutions will be required to submit a more comprehensive FAD Report three times a year to consolidate data collection. The additional reporting cycles will incorporate relevant data that was previously submitted on other reports. (e.g. TEG Need Survey and End-of-Year reports). The due dates for each submission are listed below:

First Report	December 1, 2017	January 31, 2018	Correct Errors	To collect and verify preliminary data in order to project state aid program resources for allocations and to evaluate current student financial aid needs for legislative reporting.

Second Report	May 1, 2018	June 27, 2018	Correct Errors	To collect and verify End-of-Year data to reconcile state programs funds and track student eligibility .
		August 1, 2018	Verify Data	
Final Report	August 31, 2018	November 14, 2018	Correct Errors	To collect certified data used for legislative mandated reporting.
		December 12, 2018	Certify Data	

Institutions are encouraged to allow plenty of time for error-resolution and reconciliation of data by the due dates. The FAD report must be reconciled against state financial aid program reports and CBM001 reports.

Institutions that fail to complete any of the required submissions will be subject to audit findings as well as postponement of future state financial aid disbursements.
