RE: 2017-18 Texas College Work-Study (TCWS) Final Allocation Amount

This memo is to announce the enclosed final allocation amount for the TCWS program for the 2017-18 academic year.

On May 16, 2017, preliminary allocation figures for the TCWS program were issued to institutions. Institutions were invited to confirm that the preliminary allocation spreadsheet accurately reflected the data submitted to the Texas Higher Education Coordinating Board (THECB). Institutions were allowed 10 days to review the data. That period ended at the close of business on May 26, 2017. Through this process, THECB received no comments about the data.

Of the appropriated amount, \$2.75 million is for the Texas College Work-Study Mentorship program and the \$1 million which would have funded the potential Texas Works program was added back into the allocated amount for the TCWS program. Disbursements for TCWS funds will be issued the first week after the first day of the new fiscal year, September 1, 2017.
