Allocation Amount

This memo is to announce the enclosed final allocation amount for the TEOG program for the 2017-18 academic year.

On May 5, 2017, preliminary allocation figures for the TEOG program were issued to institutions. Institutions were invited to confirm that the preliminary allocation spreadsheet accurately reflected the data submitted to the Texas Higher Education Coordinating Board (THECB). Institutions were allowed 10 days to review the data. That period ended at the close of business on May 19, 2017.

Through this process, THECB received no comments about the data. Institutions participating in the TEOG program will have the opportunity to submit a funds request form as early as **August 1, 2017** and payments for these requests will be processed the first week after the first day of the new fiscal year, September 1, 2017.
