RE: Memorandum of Understanding (MOU) for Public and Private/Independent Institutions

The Texas Higher Education Coordinating Board (THECB) announces the release of the new four-year MOU contract to public and private/independent institutions. THECB will be sending MOU's within two weeks to all public and private/independent institutions to review, sign, and return electronically by **August 4, 2017**.

In developing the MOU for distribution, Financial Aid Services integrated input from the Coordinating Board's Office of General Counsel and Office of Internal Audit, as well as the Financial Aid Advisory Committee and its appointed sub-committee. The MOU specifies the responsibilities of the institution and THECB in the administration of state financial aid programs (e.g. state grants, loans, work-study, scholarships, waivers, and exemption programs). The terms of the MOU will end **August 31, 2021.** Institutions that do not return a signed MOU will not receive funding for fiscal year 2018.

One specific change within the MOU relates to the language regarding auditing and records retention. The records retention requirement has been extended from five to seven years. Based on feedback from the Financial Aid Advisory Committee, THECB will conduct an analysis of the records retention requirement. This analysis will take time. However, if changes to the record retention requirements occur within the four-year MOU term, an amendment will be sent to all institutions.
