- July 20, 2017 Deadline to certify the EOY Report.

Field Name	Description
State Funds Awarded	
(A) Total State Allocation	Total 2016-17 TCWS allocated amount deposited by THECB into the institution's account, including reallocated funds. Manual entry on worksheet
(B) State Funds Used/Earned:1. Through Non-Profit Employers2. Through For-Profit Employers	Total State funds used/earned by students working for non-profit and for-profit employers. Manual entry on worksheet
(C) Total Awarded	The total amount of state funds used/earned. Auto-calculated on worksheet: B1 + B2 = C
(D) Balance Owed to THECB	The balance of funds that were not used/earned owed to THECB. (Any funds that have not yet been returned to THECB should be submitted using the return of funds process). Auto-calculated on worksheet: $A - C = D$
Matching & Excess Funds	
(E) Excess Funds Awarded	The total contributed institutional funds used that exceeded the state allocation (if applicable). Manual entry on worksheet
(F) Employer Matching Funds Paid 1. Non-Profit Employers 2. For-Profit Employers	Total funds matched by employer. The non-profit employer match is (25%) and the for-profit employer match is (50%) of earnings. • An institution eligible for a federal work-study matching requirement waiver is also exempt from the matching requirement for the TCWS program. Institutions must provide a copy of the current waiver from the Department of Education to the THECB. Manual entry on worksheet
(G) Total Matching Funds	The total amount of matching funds used/earned. Auto-calculated on worksheet: F1 + F2 = G
(H) Actual Amount Paid	Total excess funds, matching funds and state funds used/earned in 2017. Auto-calculated on worksheet: C + E + G = H

(I) Total Student Awarded	Total number of individual students issued TCWS funds.
	To reconcile the FADs Report to the EOY Report, each student's earnings must be rounded to the nearest dollar.
(J) Amount Reported on FADs	Example: 1,000 students paid * \$2,500.50 each (rounded to the nearest dollar =\$2,501.00)
	 Actual Amount Paid (H) = 2,5000,500 (1,000 * \$2,500.50) Amount Reported (J) = 2,501,000 (1,000 * \$2,501.00)
(K) Difference Between Actual Amount Paid vs. Amount Reported	The difference reported to account for the rounding of each student award. Auto-calculated on worksheet: J - H = K

(L) Positions Location1. On-Campus2. Off-Campus	Number of positions located on-campus and off-campus held by students receiving state funds. Manual entry on worksheet
(M) Total Job Positions	Total number of positions held on-campus and off-campus. Auto-calculated on worksheet: L1 + L2 = M
(N) Percentage of Total Positions Held Off-Campus	Total number of off-campus positions divided by the sum of the on-campus and off-campus positions. Auto-calculated on worksheet: L2 / M = N
