Purpose of Addendum:

This Addendum amends the referenced original solicitation. Specifically, the purpose of this Addendum is to change the program grant period from June 30, 2022 to September 30, 2022, with associated changes in grantee interim and final reporting schedules.

Items Changed:

Section 2.2 Grant Period

Replace "June 30, 2022" with "September 30, 2022." Replace "eight and a half (8.5) month grant period" with "eleven and a half (11.5) month grant period."

Section 8.3 Funds Disbursement and Payment Terms

Replace "June 30, 2022" with "September 30, 2022."

Section 8.4 Last Day of Expenditures

Replace "June 30, 2022" with "September 30, 2022."

Section 9.2 Project Narrative Reports

Amend language as follows:

Awarded Applicant shall submit ~~two (2)~~ three (3) written project reports as specified by THECB on or before the following dates: 1. First Interim Project Report due January 31, 2022, ~~and 2. Final Project Report due July 29, 2022.~~ 2. Second Interim Project Report due May 30, 2022, and

3. Final Project Report due October 29, 2022. Project Reports will generally include, but may not be limited to: 1. Narrative status report on the development of the TRUE project. 2. Project Work Plan. The work plan submitted with the Applicant's Application shall be updated and supplemented for each interim report and for the final report.

Section 9.3 Financial Reports

Amend language as follows:

Awarded Applicant shall submit financial expenditure reports as specified by THECB due on or before the following dates: 1. First Interim Expenditure Report due January 31, 2022, ~~and 2. Final Financial Report due July 29, 2022.~~ 2. Second Interim Expenditure Report due May 30, 2022, and 3. Final Expenditure Report due October 29, 2022.

Appendix B Calendar of Events

Amend language as follows:
