RE: FY 2021 Bilingual Education Program Final Allocation

The Texas Higher Education Coordinating Board (THECB) announces the enclosed 2020-21 (FY 2021) **final** allocation amounts, based on the reduced appropriation for fiscal year 2021 for the Bilingual Education program at seven public institutions.

Institutions participating in the Bilingual Education Scholarship program are required to use funds only for grants to provide financial incentives in the form of tuition assistance. The program aims to encourage students who enroll in an educator preparation program at the university to become certified to teach bilingual education, English as a Second Language, or Spanish in school districts with high critical needs.

Disbursements for Bilingual Education funds will require an institution to submit a fund request form and payment for these requests will be processed after the first day of the new fiscal year, Sept. 1, 2020.
