RE: State Campus-Based Programs Report - FY 2021 (2020-21)

The Texas Higher Education Coordinating Board (THECB) is required to collect data on state campus-based programs and retain current guidelines for administering the Texas Public Educational Grant (TPEG) program from each public institution.

Enclosed is the required report that **participating** private and **all** public institutions will use to submit data for the 2020-21 (FY 2021) academic year. The deadline to upload the completed report, excess amount of funds (if applicable), and a current copy of each institution's TPEG guidelines (which must include an "As-Of" date) to the THECB is **Nov. 19, 2021**.
