Subject: 2021-22 (FY 2022) State Campus-Based Annual Report

The Texas Higher Education Coordinating Board (THECB) is required to collect data on state campus-based programs and retain current guidelines for administering the Texas Public Educational Grant (TPEG) program from each public institution.

Enclosed is the *fillable* required report that **participating** private and **all** public institutions will use to submit data for the 2021-22 (FY 2022) academic year. The deadline to upload both the completed report and a current copy of each public institution's TPEG guidelines (which must include an "As-Of" date), and to return any excess amount of funds (if applicable) to the THECB is **Oct. 28, 2022**.

Complete the following steps to submit this report:
