RE: FY 2022 (2021-22) and FY 2023 (2022-23) Texas Educational Opportunity Grant (TEOG) Final Allocations

On June 3, 2021, the Texas Higher Education Coordinating Board (THECB) issued 10-day allocation data review materials to institutions for the TEOG program. Institutions had 10 business days to review the data, with the review period ending June 17, 2021. Through this process, the THECB received no comments about the data.

Enclosed are the **final allocations** for fiscal year (FY) 2022 (2021-22) and FY 2023 (2022-23) for the TEOG Grant program. Please note that the THECB received additional state appropriations for the state grant programs through the B.1.10 Strategy in the General Appropriations Act, SB 1, 87th Texas Legislature, Article III, which is reflected in the increased final allocation amounts.

Institutions participating in the TEOG program can begin to submit an online funds request form for FY 2022 through the Grant Payments Portal (GPP) beginning Aug. 2, 2021 and payment for these requests will be processed after the first day of the new fiscal year, Sept. 1, 2021.
