Subject: 2023-24 Texas Application for State Financial Aid (TASFA)

The 2023-24 Texas Application for State Financial Aid (TASFA) is now available on the <u>College for All Texans</u> website and the Student Financial Aid Programs (SFAP) information webpage under <u>Program Resources</u>.

The following changes were made to the 2023-24 TASFA based on recommendations by the Financial Aid Advisory Committee's TASFA Subcommittee and the Texas Higher Education Coordinating Board (THECB):

- Annual updates to years, dates, and the tax and income references from the Internal Revenue Service (IRS).
- Questions were reorganized to align with the development of the future Online TASFA.
- Proof of Selective Service registration is no longer required and was removed from the Selective Service Statement of Registration Status form.
- Removal of the following TASFA questions:
 - Date of graduation (HS or GED) #17
 - College grade level #19
 - Degree/certificate attempting #20
 - Number of credits/hour enrolled #22
 - Associate degree for transfer students #23
 - Conviction restrictions #25
 - Previously received state aid #26
 - Work authorization and work-study interest #27
