RE: FY 2022 Texas College Work-Study (TCWS) and Work-Study Mentorship Program (WSMP) 10-Day Allocation Data Review

The Texas Higher Education Coordinating Board (THECB) announces the 10-day allocation data review for the 2021-2022 (FY 2022) Texas College Work-Study (TCWS) and Work-study Mentorship Program (WSMP) for institutions of higher education and private or independent institutions of higher education. As part of the allocation rule (TAC, Section 22.133) and (TAC, Section 22.134), a 10-day review period is required, allowing institutions to review the data that is provided in the enclosed attachment, **"TCWS Preliminary Allocation Calculation Data"** and **"WSMP Preliminary Allocation Calculation Data.**"

The preliminary allocation calculations are based on institutional data submitted on the FY 2020 Financial Aid Database and the Opt-In/Out survey for state financial aid programs due on March 12, 2021.

As part of the 10-day review process, an institution can choose to Opt-In/Out of the Texas College Work-Study or Work-Study Mentorship program. Please review the enclosed data and advise Financial Aid Services staff of any discrepancies by the close of business on **June 17**, **2021** by sending an online inquiry to <u>CONTACT US</u> (select the "Financial Aid Question" option in the drop-down selection under **Contact Reason**). **Failure to respond will be interpreted as confirmation that the school's data is accurate.**

This announcement does not imply any official allocation of funds for an institution. For illustrative purposes, tentative allocation levels have been provided based on the THECB's B.1.5 Strategy in the General Appropriations Act, Enrolled, Senate Bill 1, 87th Texas Legislature. Of that appropriation amount, \$3.75 million has been tentatively reserved for the Texas College Work-Study Mentorship and the Texas WORKS programs. Once the General Appropriations Act has been signed by the Governor, official FY 2022 TCWS and WSMP allocations will be disseminated to the institutions. Any institution offering aid prior to official allocation announcements from the THECB does so at its own risk.
