RE: 2019-20 (FY 2020) Texas College Work-Study (TCWS) Final Allocation

This memo is to announce the enclosed 2019-20 final allocation amounts based on the appropriation from fiscal year 2020 for the TCWS program.

On April 4, 2019, the 10-day allocation data review materials were issued to institutions for the TCWS program. Institutions were invited to confirm that the "TCWS Preliminary Allocation Calculation Data" accurately reflected the data submitted to the Texas Higher Education Coordinating Board (THECB). Institutions were allowed 10 days to review the data which ended on April 18, 2019. Through this process, THECB received no comments about the data.

The legislative appropriation for the standard Texas College Work-Study Program also provides funding for both the Texas Work-Study Mentorship and the Texas WORKS (Working Off-Campus: Reinforcing Knowledge & Skills) programs. This memo only communicates the portion of the appropriated funding to support the standard program. The allocation for the Mentorship Program will be sent separately. Disbursements for TCWS funds will be issued after the first day of the new fiscal year, September 1, 2019.
