RE: Financial Aid Database (FAD) Reporting Cycle Two - 2019-2020 (FY 2020)

The Texas Higher Education Coordinating Board (THECB) will begin accepting files June 22, 2020 for the 2019-20 (FY 2020) FAD Reporting **Cycle Two**.

Enclosed is the updated FY 2020 FAD manual, which is also available on the <u>Student Financial Aid Programs website</u> under **Online Resources**. Please replace all previous copies of the FY 2020 FAD manual to ensure that financial aid administrators submit all files accurately. The following are the major changes in the manual:

- Added "update symbol" to highlight edits made to the file layout.
- Updated the reconciliation report to reflect "Warning" for Cycle Two.
- Updated the Program Comparison report to reflect all financial aid programs.

Institutions will not be required to reconcile state aid programs during Cycle Two; reconciliation will occur during reporting Cycle Three. For each program that is flagged "WARNING" on an institution's FAD Reconciliation Report, the institution should review the totals to prepare for the reconciliation process during Cycle Three. Student loan details have been uploaded into each institution's FAD_Output folder in MOVEit to assist with the review process. The file is named "EOY Student Loan Details 6_16_2020."
