<ul style="list-style-type: none"> \$16 billion appropriated for higher education. THECB budget increased from \$1.6 billion to \$1.8 billion. Legislature restored the 5% funding reductions required in agency's Legislative Appropriations Request (approved \$57 billion across grant programs TEXAS Grant, TEOG, TEG) bringing funding back up to the FY 2020 funding levels. Legislature approved THECB's exceptional item request - an additional \$110 million for the same above-mentioned grant programs. SB 1 moves funding and FTEs for Texas OnCourse program to Coordinating Board from UT-Austin. SB 1 includes rider language that gives flexibility around employees that support College Access Loan Program. SB 1860 extends previous deadline for implementation of an electronic TASFA. SB 1888 allows higher performing students to graduate early from high school, attend public universities and receive scholarships regarding the same. SB 1019 directs the Coordinating Board to provide data on student borrowers disaggregated by categories: sex, ethnicity, etc. and data to be made available in the Student Financial Aid Report. - Would be helpful to collect ideas and samples as to what institutions are doing regarding EA and place them on the TASFAA website.
- Presenting business plans for hiring additional staff to help administer EA and HEERF



Executive Summary

Texas Education Code (TEC), Title 3, Chapter 56, Section 56.311(c-1) requires that the Texas Higher Education Coordinating Board (THECB or Coordinating Board) annually provide the Legislature a report on the Toward EXcellence, Access, & Success (TEXAS) Grant Program. This report provides a series of appendices to conform with the statutory expectations. The following information is provided from the three preceding state fiscal years:

- Allocations of TEXAS Grants by eligible institution
- Number of TEXAS Grants offered, disaggregated by race, ethnicity, and expected family contribution
- Number of TEXAS Grants offered through the Priority Model or through other eligibility criteria, also disaggregated by race, ethnicity, and expected family contribution
- Persistence, retention, and graduation rates of TEXAS Grant recipients

The TEXAS Grant Program remains the state's signature student financial aid program for financially needy, academically prepared Texas students enrolled at Texas public universities. The intent of the program is to ensure that tuition and fees for these students are covered if they continue to meet program requirements. This intent is reflected in the requirement that maximum annual grant amounts be equal to the statewide average amount of tuition and fees at Texas public universities, as well as the requirement that institutions offer non-loan aid to cover any difference between the amount of tuition and fees owed by a student and the amount of the TEXAS Grant offered to the student.

The Texas Legislature initially appropriated \$866.4 million for TEXAS Grants for the 2020-2021 biennium.¹ Despite this substantial appropriation, the continued increase in the number of eligible students, in addition to increased tuition and fees at public universities, has outpaced the program's ability to cover students' tuition and fees.

In Fiscal Year (FY) 2020, a total of 82,697 students received TEXAS Grants. The THECB encouraged institutions to assist as many students as possible through a recommended "target" grant of \$2,500 per semester. While most institutions implemented target-level grants, the gap between the amount of tuition and fees owed and the amount of students' TEXAS Grants continues to grow, requiring institutions to devote increasing amounts of institutional resources to close this gap.

In FY 2020, Hispanic students represented 38% of all Texas students enrolled in public higher education, while 58% of all TEXAS Grant recipients were Hispanic students, a 20-point difference. The reverse is true for white students, while African American and Asian student representation among TEXAS Grant recipients mirrored their representation in the overall student population.

The distribution of TEXAS Grant recipients by Expected Family Contribution (EFC) has changed very little during the three-year period reported. In FY 2020, more than half of all recipients had EFCs equal to zero, and an additional 36% had EFCs of less than \$4,000.

The "Priority Model" was implemented in fall 2013 (FY 2014) for students receiving first-time TEXAS Grants. This model prioritizes offering grants to students who are better prepared academically and are more likely to graduate. With this model, students who meet at least two

of four criteria representing greater college preparedness receive priority over students meeting basic program eligibility requirements for initial grants.

The four-year graduation rate for students qualifying for grants under the Priority Model was 15 percentage points higher than for students meeting the Basic Eligibility requirements as fall 2016 entering freshmen. The six-year graduation rate for all TEXAS Grant recipients who entered college as freshmen in fall 2014 was 3 percentage points higher than the previous year, at 59%.

The rates of retention in the program from one grant year to the next are notably higher for the five cohorts of students who qualified for initial grants under the Priority Model than for those who entered the program under the Basic Eligibility requirements. The number of students from the three most recent Priority Model cohorts (2017, 2016, and 2015) receiving fourth-year grants was 17, 12, and 14 percentage points higher than those entering the program under the Basic Eligibility requirements.

TEXAS Grant Operations

Expected Family Contribution

Expected Family Contribution (EFC) is calculated based on a federal statutory formula established to determine how much the student's family can be expected to contribute toward the student's education costs in an academic year. In determining which students receive an initial grant from funds remaining after renewal grants, institutions must assign the highest priority to students who meet the Priority Model requirements and whose EFC does not exceed 60% of the statewide average amount of tuition and fees for that academic year, shown below for FYs 2018-2020:

- FY 2018: \$5,430
- FY 2019: \$5,609
- FY 2020: \$5,875

TEXAS Grant Eligibility

Statutory reporting requirements include a breakdown of TEXAS Grants offered through the Priority Model or through Basic Eligibility, as well as through Initial-Year or Continuing grants. These designations are described below.

Basic Initial-Year Eligibility

- Is a Texas resident
- Demonstrates financial need
- Has applied for all available financial aid
- Does not have a baccalaureate degree
- Is enrolled at least three-quarter time
- Has not been convicted of a felony or crime involving a controlled substance
- Is registered with Selective Service
- Is enrolled as an undergraduate in a baccalaureate degree program through one of the following pathways:
 - High School Pathway: within 16 months of high school graduation
 - Military Pathway: within 12 months of an honorable military discharge (must have enlisted within 12 months of high school graduation)
 - Associate Pathway: within 12 months of receiving an associate degree
 - Texas Educational Opportunity Grant (TEOG) Pathway: after having received a TEOG, the state's primary grant program for students attending two-year institutions, and having completed at least 24 credit hours at a Texas institution with at least a 2.5 Grade Point Average (GPA)

Priority Model Eligibility

In addition to meeting Basic Eligibility requirements, a student must meet at least two of the following four criteria to be considered through the Priority Model:

- Advanced coursework: earn 12 hours of college credit courses (e.g., dual credit or advanced placement); or graduate under the Distinguished Level of Achievement High School Plan or the International Baccalaureate Program
- Advanced math: complete a math course beyond Algebra II

- Academic achievement: rank in the top third of high school graduating class or attain a B average
- College readiness: achieve a college readiness threshold as determined by the Texas Success Initiative

Continuing Eligibility

In addition to the requirements for Basic Initial-Year Eligibility, to receive a grant in the years following an initial grant, a student must meet satisfactory academic progress expectations:

- Meet institutional Satisfactory Academic Progress (SAP) requirements at end of initial grant year
- Maintain program SAP requirements by completing at least 24 semester credit hours and achieving a 2.5 or higher GPA for each year following the initial grant year

Enrollment Pathways

There are four pathways under which students may be eligible for the program: High School, Military, Associate, and TEOG. The TEOG Pathway did not take effect until FY 2016. As seen in Table 1, the percentage of TEXAS Grant recipients in the Associate and TEOG pathways continues to lag behind each pathway’s share of the eligible population (34.9% of eligible students in FY 2020 were in these pathways, but only 4.4% of students who were eligible through these pathways actually received TEXAS Grants).

Allocation Methodology

TEXAS Grant funding is appropriated to the THECB and then allocated among public universities and health-related institutions (HRIs) in accordance with a defined methodology. This methodology was revised by a negotiated rulemaking committee in 2016 and became effective in FY 2017.

The allocation methodology has two steps. First, the number of renewal students by institution is estimated based on past attrition rates and is multiplied by the institution’s average grant amount, capped at a \$5,000 grant. Second, the number of all eligible new students at each institution is divided by the number of eligible new students statewide and then multiplied by the total amount of remaining appropriations.



This topic will discuss any updates within the Student Financial Aid Programs (SFAP) division.

General agency updates:

- A notice was sent out on July 13 (attached) from the Commissioner announcing additional GEER funding. Our agency was awarded an additional \$94.6 million in federal funds for higher education by Governor Abbott and the legislative leadership. This new round of funding, which comes from the federal CARES Act Governor’s Emergency Education Relief (GEER) fund, will continue to provide meaningful support for Texas students and institutions, especially to ensure students have the skills they need for tomorrow’s jobs, while expanding access for adults, transfer students, and students who are low-income, and increasing institutions’ capacity to deliver high-value postsecondary programs.

Some of the GEER funds are earmarked for the agency to continue their efforts with modernizing our data infrastructure along with providing resources and tools for students. Below is a breakdown of what divisions within our agency will be working with these initiatives and which GEER funds are available to schools. It appears that most of the GEER grant initiatives are for public institutions. As I learn more about the funds, I will definitely share the information.

- **Institutional Capacity Grants** will be handled by our Workforce Education Division and will be available to public institutions to complete a Request For Information (RFI). More information will be provided when these funds are available to request.
- **Texas Reskilling Support Fund Grants 2.0** will be handled by our Workforce Education Division and will be available to public institutions to complete a Request For Information (RFI). More information will be provided when these funds are available to request.
- **Financial Aid Pilot Programs**
 - o **Texas Leadership Scholars Program** will be handled by our Academic and Health Affairs Division. More information will be provided when these funds are available to request.
 - o **Texas Transfer Grants** will be by our Student Financial Aid Programs and will be available to public institutions. More information will be provided when these funds are available to request.
- **Student Success & Equity Initiatives** will be handled by our College, Readiness and Success Division. These funds are earmarked for the agency to continue to provide resources and tools for students.

- **Student Engagement and Educator Training** will be handled by our College, Readiness and Success Division. These funds are earmarked for the agency to continue to provide resources and tools for students.
- **GRADTX 2.0 Expansion** is will be handled by our College, Readiness and Success Division. These funds are earmarked for the agency to continue to provide resources and tools for students.
- **DATA SECURITY AND ACCESSIBILITY** will be handled by our Information Support and Services Division. These funds are earmarked for the agency to continue our efforts with modernizing our data infrastructure.

Quick update on the agency website redesign:

- The agency is still working with a consulting team to launch the redesigned agency and data websites. Our goal is to be complete with the first phase of this initiative by August.

Transitioning Memorandum of Understanding (MOU) Contracts to Program Participation Agreements (PPA): July 13

The Texas Higher Education Coordinating Board (THECB) will be transitioning from a four-year Memorandum of Understanding (MOU) to a new two-year Program Participation Agreement (PPA) for all public and private/independent institutions of higher education. This new simplified three-page agreement will cover fiscal year (FY) 2022 and 2023 and be renewed every two years to align with the beginning of each biennium following the legislative session. In developing the PPA for distribution, Financial Aid Services integrated input from the Coordinating Board’s Office of General Counsel and Office of Internal Audit. The PPA specifies the responsibilities of the institution and the THECB in the administration of state financial aid programs (e.g., state grants, loans, work-study, scholarships, waivers, and exemption programs).

The THECB will be sending the new PPA to the Director of Financial Aid in the next two weeks at all public and private/independent institutions along with instructions. All current MOUs will expire on Aug. 31, 2021 so please email the signed copy of the PPA to DeCha.Reid@highed.texas.gov by Aug. 18, 2021 to allow enough time for processing by the THECB. Institutions that do not return a signed PPA cannot receive funding for FY 2022 or FY 2023 until it has been received and executed.

- **Updates on initiatives**
 - **Update on TASFA/eTASFA:**

Below is a brief update on the progress of the paper TASFA and online TASFA development.

- The FY 2023 paper TASFA is set to go out to institutions the first week of September to allow schools the ability to customize, upload to their websites and update their own vendors for those that have online versions. Minimal changes are being made this year since we expect a lot of major changes due to FAFSA simplification which will in turn, effect TASFA. The only modifications that were recommended this year are:
 - Updating the TASFA to allow female students to mark they are exempt from registration.
 - Changing the selective service section from bright red to a less harsh color.
- Last meeting, we were currently monitoring HB3273 and SB1860, regarding the legislative request to extend the availability of the online

application to the 2023-2024 academic year. This legislation passed during the 87th session which now allows the THECB more time for development, testing and launching the online TASFA.

- We are starting to review user stories which will further help with development and iron out functionality flaws prior to actual testing.
- We are also working on the file layout so we can meeting again with vendors in early August to discuss possible limitations, challenges or programming needs. The goal is to make the file something that requires minimal programming or manipulation to import on the institution side, if possible.
 - **Committee Feedback on TASFA Acknowledgment:**
 - Currently is not sending any true acknowledgement, only the award letter for students who have applied or enrolled
 - Update the student portal to provide updates on the process (UT-Austin and Texas State)
 - There isn't a consistent process amongst schools on what they do with TASFAs received for students that have not officially applied. Replying to students via email to provide a confirmation could present a challenge to schools with smaller staff, less resources or less robust portal systems
 - Letting schools know to prepare for a possible influx of TASFAs and even ISIRs due to this new requirement would be helpful.
