









HR managers know the toll mental illness can take on the company. Yet, only **15%** feel managers are training to recognize the problem and share support and resources.






The most common reason why students consider leaving college is the high cost, followed by mental health challenges. Difficulty finding ways to pay for school wraps up the top 3.

Among women, 'Mental health challenges' were the top response, slightly edging out 'The cost is too high'

Notably, the average student selected 2.88 options. This shows how connected these issues are. One example of this: mental health challenges might lead to a student feeling like they don't belong, or vice versa.




Mental illnesses are associated with higher rates of disability and unemployment:

- Hinders ability to complete physical job tasks about 20% of the time
- Reduces cognitive performance about 35% of the time
- Only 57% of employees report moderate depression
- Only 40% of those report severe depression receive treatment

Update on Online TASFA

This topic will provide an update on the progress of the online TASFA, as well as the paper application.

Update:

- We are continuing to refine the Online TASFA and are progressing with our internal and external user acceptance testing.
- Iteration 1, where we tested the independent student process and iteration 2, where we tested the dependent student process have been completed. We are gearing up to start iteration 3 testing where we will test submission to additional colleges and emails sent to users. After iteration 3, we will work on iteration 4 testing where we will test the full application process this includes submitting an initial application, resubmitting to additional colleges, printing out a copy of the submitted online TASFA, and all application functions.
- Institutional test files are still being programmed, additional testing is necessary before test files are released.
 - Looking into creating a .CSV or another file type as an alternative method
