- Representative John Kuempel is the chair for the House Higher Education Committee
- Major funding and policy items:
  - o Both chambers have introduced their first draft appropriation bills; introduced bills keep financial aid programs funding levels even with previous biennium.

- THECB has requested additional financial aid assistance through Texas Grant, TEOG and TEG to keep those
  grants at the same service level as the last biennium so the same percentage of students can be served through
  those programs.
  - Senate Finance Committee & House Appropriations Committee meeting to discuss the budget proposals.
- o HB8- Legislation to enact the recommendations made by the Community College Finance Commission.
  - Looking at how to fund community colleges & keep them affordable.
  - Recommendation: an increase in TEOG funding so that the TEOG program could serve 70% of eligible students (currently only serves approx.. 25-28% of eligible students).
  - Funding for this was included and will only happen if legislation is passed.

Proposed Rule(s)	Proposed Amendments
19 TAC §22.1	In 22.1, the definition of "expected family contribution" is amended to reflect that the phrase refers to the applicable federal methodology.
19 TAC §§22.22 - 22.24, 22.28, 22.29	In §22.22, two redundant definitions are repealed since the items are explained elsewhere in the subchapter. In §22.23, the timing of data submissions is clarified to ensure that allocation activities can occur in a timely manner. In §22.24(8), eligibility criteria are provided for exceptional TEG need. In §22.28, a clarifying reference to §22.4 is added. In §22.29, outdated language is removed, with appropriate clarifying language. Section 22.29(c) is also removed since the language is being proposed separately as a new §22.30.
19 TAC §22.30	In 22.30, this new section will establish language currently in §22.29 as a separate rule for greater clarity.
19 TAC §22.49	In 22.49 will implement new standards regarding the aggregate and annual loan limits.

## Another proposed rule change that we are interested in getting feedback on would impact community colleges.

Before we submit a request for a proposed rule change, we were hoping to get your input on whether you think the Coordinating Board should consider calculating two maximum TEOG amounts: an in-district amount and an out-of-district amount.

The statute does not distinguish between in-district vs. out-district: <u>TEC 56.407(a)</u> indicates, "the amount of a grant under this subchapter for a student enrolled full-time at an eligible institution is the amount determined by the coordinating board as the average statewide amount of tuition and required fees that a resident student enrolled full-time in an associate degree or certificate program would be charged for that semester or term at eligible institutions." This can be interpreted as both in-district and out-of-district students are residents.

However, our rule for calculating the maximum grant is based on in-district resident tuition and fees. (19 TAC §22.261(b)(2)). We understand that this can lead to some funding challenges at some community colleges, since out-of-district resident tuition and fees are usually several thousand dollars more than in-district resident tuition and fees. TEOG requires institutions to ensure that any TEOG recipient is receiving grant funds to cover tuition and fees. Many community colleges do not have significant institutional funds to draw from to cover the difference between the maximum TEOG and a student's out-of-district resident tuition and fees, and thus they may avoid offering TEOG to out-of-district students.

We are proposing to re-write our rule to calculate both an in-district maximum and an out-of-district maximum to provide institutions with greater flexibility in the utilization of their funding to support the goals of the TEOG program. What are your thoughts on this proposal?

If the TEOG appropriation increases that have been proposed by the Community College Finance Commission are approved, having an out-of-district maximum may be essential to ensuring institutions can execute the increased funding level.

# **Update on Online TASFA**

This topic will provide an update on the progress of the online TASFA.

# **Update Online TASFA:**

- We are continuing to refine the Online TASFA and are progressing with our internal and external user acceptance testing.
- There is no official launch date, but will be available this summer.
- TASFA webpage is built along with the application; waiting for final approval on the e-signature.
- Batch process has been tested internal and externally from members of the TASFA committee
- Goal is to deliver test files to all institutions and training webinars
- Will do smoke screening testing for four weeks.
- For 2023-24, we suspect that many students have already applied so the number of students may be small which will help with the refinement
- For 2024-25, starting the process to see how FAFSA will impact the online and paper TASFA. Will be comparing the ISIR and FAFSA layout to determine what changes need to be done with the TASFA. The paper application will continue to be released by Oct. 1.

- For security purposes, Financial Aid Directors or the person who we has access to FAD Data Certification will be given access to the Data Submission application.

# **Topics of Discussion:**

- Update on Legislative session
  - Texas Commission on Community College Finance: HB 8 by VanDeaver/SB 2539 by Creighton would fully implement the TXCCCF recommendations, including a transition to outcomes-based funding and creation of a dual credit scholarship program for low-income students.

     HB 8 has been sent to the Senate. We expect Senate Education (SEC) to vote on the bill as soon as there is an agreed upon substitute.

DeCha R. Leah S. Tanitia C.

- Both House and Senate budgets include a \$650 million contingency for this legislation.
- Texas Leadership Scholars Program: SB 902 by West/HB 1590 by Burns would codify the Coordinating Board's existing Texas Leadership Scholars Program.
  - · Both SB 902 and HB 1590 have moved to the second chamber.
  - Both House and Senate budgets include \$20 million to fund this program.
- Texas Armed Services Scholarship Program (TASSP): HB 1192 by Turner/SB 371 by Eckhardt would allow students to participate in TASSP for each year they complete ROTC training at a Texas IHE.
  - · SB 371 has been referred to House Higher Education (HHEC), and HB 1192 is in House Calendars.
  - Both House and Senate budgets include an additional \$8 million for TASSP.
- Texas First Expansion: SB 2294 by Creighton/HB 4434 by Kuempel would expand the Texas First program to include all public IHEs, rather than only research and emerging research universities.
  - · HB 4434 and SB 2294 were both passed to engrossment on April 24th.
- Healthcare Workforce: SB 25 by Kolkhorst would expand the current nursing faculty loan repayment program (NFLRP) to include part-time faculty and allow THECB to set the maximum award amount. The bill would also revamp existing statutory provisions for nurse scholarship and loan repayment programs that haven't been funded for many years.
  - · SB 25 has been referred to HHEC.
  - Senate budget includes a \$25 million contingency rider for these two programs, and both the House and Senate budgets also include an additional \$7 million for the NFLRP.

In addition, we are also following these items:

 Transfer grants: Both SB1 and HB1 have a rider allocating \$10 million annually to create a transfer grant program

- Competency-based grants: HB4005 has passed the house and SB0462 has passed out of committee in the Senate. Sen.
   Creighton is sponsoring a contingency rider to fund the program.
- TEOG: HB8 more than doubles the amount of TEOG funding and the Commissioner is interested in making TEOG available to students enrolled in continuing education certificates
- FAST Exemption: HB 8 includes Financial Aid for Swift Transfer (FAST) which is basically a guaranteed exemption funded by the state for educationally disadvantaged students (i.e. eligible for free or reduced lunch) taking dual credit courses.
- Mental Health: Funding for the program is increasing form roughly \$1million annually to \$14 million annually.

We have the potential for half a dozen new aid programs, as well as major modifications and funding increases for another half a dozen programs

# Update of state programs:

- Texas First Scholarship and FORWARD Loan process
  - Texas First Scholarship: There are 10 eligible schools that can participate in the Texas First Scholarship program. The program has been added to the 2022-23 FAD year. One of the main question we have received is how to pay students and what is the process? Institutions will pay the student up front and be reimbursed after the school reports funds on the FAD report. We plan to send out a fact sheet and schedule a meeting with the eligible institutions in the coming weeks to go over the certification and disbursement process. TEA is working on adding the diploma to the academic record and THECB is working on creating a form to determine which students will graduate under the Texas First diploma in order to provide a certificate of state credit.
  - FORWARD Loan Process: At this current time, we received over 100 applications for both 2022-23 and 2023-24 school years. The challenge is schools completing certification in order for THECB to review for manageable debt. We have been able to approve an application and deny a few based on

exceeding the manageable debt threshold. It is too early to report what we have learned until we have more applications to review. We are focusing on helping schools with the certification process.

- Transfer Grant and Texas Leadership Scholarship-future funding
  - Transfer Grant: As I stated in the Legislative Update, this program has a rider allocating funds however we will know closer to mid-May if \$10 million is the final amount. The Transfer Grant program may be administered differently than this past year. We will provide details as we learn more.
  - Texas Leadership-This is the same as Transfer Grant, where funding has been allocated and the program may have some slight changes. More information will become available as we see bills pass.

# Update on Approved Proposed Rules

 CAL Manageable Debt and other rules impacting TEG have been approved by the Board. This means that CAL will undergo the same manageable debt calculation like FORWARD beginning with applications that are submitted on or after 9/1/23. Institutions that use Commonline to certify loan applications will be impacted.

# Update on Allocations for 2023-24 & 2024-25

 THECB plans to release the 10-day data for preliminary allocations starting in early May. The data will go to the Financial Aid Directors. The programs for review will be the three grant programs, Educational Aide, and Workstudy.
