- Agency is looking for \$153 million dollars to support financial aid programs (three grant programs) to support the same eligible students from the current biennium (same service level); requested state general revenue funding to support new programs:
 - **Transfer Grants**
- Texas Leadership Scholarship Program
 Texas Commission on Community College Finance

- The commission is to help improve the finance of community colleges; a draft from then commission is to increase
 funding in TEOG to support the same student percentage in TEOG as does Texas Grant; greater flexibility of TEOG;
 new state financial aid program to cover tuition and fees in dual credit; expanding partnerships for paid workforce
 programs (work-study); final report in Jan 2023.
- Agency will not adopt a formal policy agenda for the Legislative session; we will work with institutions and other stakeholder to make the best decision possible on higher education.
- Tough to say what will be the hot topics for the Legislative session but will know more in December when the bills start being filed.

- The survey revealed some areas that the agency believed would be the needs of the FA Community; still looking through survey results
- More to come as the agency continues to work through the structure of expanding access; multi-years to achieve the goal.
- Another area funded through GEER funds is the Transfer Grant program, looking potentially providing spring 2023 grants to
 recipients but will need the reimbursement rosters to make that determination since enrollment is key to making additional
 funds available.

- Bridgette: Created a form for the fresh start, happy to share with the committee; received a few letters, only have eight students in 2022-2023 and created a report to identify other students.
- Rachelè: Only had one student that was impacted and plan to meet about the process. The timing was during announcement of Loan Forgiveness and was still working through those calls.
- Scott: Received one student before the guidance came out and created their own form to work through the guidance.
- Robert: Had about ten students and working through a report to identify more students; created a form. Notices that students are requesting more funds once they have been refreshed, require a student to request the maximum amount then plan to meet for next year.
- Melet: Received two students to refresh and noticed that the messaging has not been accurate or aligned with what the Department of Education.
- Thomas: Only received one letter and checked NSLDS and could not locate the student was on default. There have been some issues with NSLDS reporting that could be impacting the student.
- Lynda: Experiencing students are meeting the aggregate loan limit or have little availability remaining.
- Gilbert: Is there a solution to resolve the default that impacts the students that are being refreshed.

THECB Work-based learning programs

Work Study Student Mentorship Program (WSMP)

Focus: Improve and increase student access, success, completion of education goals and to provide employed WSMP students with an opportunity to gain and strengthen career readiness skills.

TXWORKS Internship Program

Focus: Provides students with opportunities to build their resumes through paid and professional work experiences aimed at strengthening their career readiness.





Work-Study Student Mentorship Program

The purpose of WSMP is to provide employment to eligible students with:

Established financial need to mentor, tutor, or advise students at participating institutions of higher education or high school students within local school districts and nonprofit organizations.

These student mentor, tutor, and advising positions are funded by a combination of state appropriations provided by the Texas College Work-Study (TCWS) Program and matching funds from participating institutions.

Work-Study Student Mentorship Program provides:

- Part-time employment to eligible students as mentors, tutors, or advisors.
 - Wages/work requirements:
 - minimum of \$10 an hour
 - maximum of 20 hours per week
- Training as determined by the THECB and participating institutions.
- Program oversight.
- Matching funds, including partner match.

TEXAS INTERNSHIP CHALLENGE

Supported by **THECB**

TXWORKS is a program that provides students with opportunities to build their resumes through paid and professional work experiences aimed at strengthening their career readiness.

TXWORKS

- Opportunities for meaningful, challenging, real-world work experiences.
- Exploration of career paths with professional development and certification opportunities as applicable.





TXWORKS

- Work a minimum 8 weeks and a minimum of 96 hours.
- Earn a minimum of \$20 per hour.

Example:

- \$20 * 12hours/week =\$240/week * 8 weeks = \$1920/internship period
- THECB reimburses \$960 to the employer.



Employers and Interns negotiate schedules.

Employers can offer more than \$20 per hour.





An Intern can work 2 consecutive periods.



TXWORKS

Internship activities are not political or sectarian in nature and with no more than 25% administrative work.

Internships can be offered face-to-face, virtually or hybrid.

No more than 50% of the eligible employer's workforce may be interns.

 - a. Employer information form
 - b. Capacity plan
 - c. Submit THECB vendor documents to be reimbursed

Going Merry is a financial aid platform used by students and counselors in 2 out of 3 US high schools, including over 2,000 in Texas.

We've built a new, better FAFSA for students and counselors. It uses simple questions with helpful tips so students don't get stuck and offers students and parents customer service for additional support. In addition, schools have a dashboard with real-time stats on their students' progress through each section and question of the FAFSA.

House Bill 3 requires 100% FAFSA Completion

 House Bill 3 was signed into law in 2019 and states:


"Before graduating from high school, each student must complete and submit a free application for federal student aid (FAFSA) or a Texas application for state financial aid (TASFA)."

- This requirement went into effect this year
- Understanding how to complete the FAFSA is a required TEK (Texas state standard) in the Economics course (this course is required for graduation)



Texas missed last year's target by ~30%

- Completion was up 10% year on year for the class of 2022
- However, that was still only 67% completion
- Completion needs to increase nearly +50% year on year (vs. +10% y/y in 2022, and -3% y/y in 2021)



Why is Texas unlikely to meet its

FAFSA graduation requirement?

It is Hard for Students to Complete

Kids have a mentality that the form is complicated and takes a lot of time

Students get stuck and wait a month to finish it... I want to get them to do it earlier so it's not so stressful First-generation and undocumented students get confused and have little support

Creating an FSA ID is confusing and they spend 15 mins remembering what it is each time they log in

Students and parents
make mistakes when
they're not sure how to
answer a specific
question then it's more
trouble helping them fix it

It is Hard to Get Parents to Complete It

Parents are intimidated & confused, particularly about tax information and who should enter what in case of nontraditional families

Getting documentation from families is a nightmare

Parents are hard to get hold of /
unwilling to share data /
concerned about information
privacy

We never know if a parent has signed or not

FAFSA Reporting is Poor and Inconsistent

It's hard to track each students' progress, who's stuck, who's completed it, who's signed it, etc. If we can't track that, we can't remind them

Tracking is a challenge in TX. Higher Education Coordinating Board gets data from Federal Government but we have so many discrepancies

Real frustration is reporting and inconsistency between Apply Texas and Dept of Ed data



On key item that changed this year was the start term for new committee members. The FAAC agreed to amend the rules for the nomination cycle to allow new members to start in September. The change was based on wanting to better align a committee member start term with the state fiscal year (Sept. 1) and the ability to elect a new Vice Chairperson earlier, along with ensuring there was enough representation from all sectors outlined in the Committee Administrative Rules.

In addition, FAAC's subcommittees actively engaged with THECB staff on several key agency initiatives and policies to help support the advancement of the agency goals and missions. Below are some highlights from the subcommittees:

TASFA Subcommittee: The TASFA Subcommittee continued to work on the online and paper TASFA to improve the student and institutional experience in delivering information on state aid. A non-inclusive list of activities included:

- Engage stakeholders with user acceptance testing for the online TASFA.
- Held multiple trainings to provide a preview of the online TASFA process.

Data Collection Subcommittee: Data Collection Subcommittee continued to work with THECB staff on the agency initiative to improve the importing of institutional data through the Financial Aid Database (FAD) data modernization project, along with providing guidance on the following topics:

- Texas Transfer Grant Pilot program
- Collection of the Selective Service Registration Statement
- Authority to Transfer Process for grant and work-study funds
- FAD Certification process

The members of FAAC are appreciative of the Board's approval for the continuation of the committee and offer the following examples of why the FAAC is important:

- The opportunity to share information helps both the agency and the institutions make informative decisions related to financial aid concerns and challenges in higher education.
- Provides a platform to identify key services and ways to successful administer programs supporting Texas residents in the pursuit of higher education.

 - Effective March 1, the agency reduced the interest rate on certain CAL loans from 5.25% to 3.75%. These are loans made between August 2011 and October 2013 and impacts of 6,500 loans. We were able to reduce the interest rate due to the recent interest rate changes. On April 1, THECB will reduce approximately 5,500 loans (reduction of 0.25 5.25% to 5.00% and 450% to 4.25%). All borrowers who were impacted were notified.
 - The following memos were recently released:
 - B.1.10 Strategy Funds Request released on 3/1/2022: This announcement outlined the process to request the additional B.1.10 funds through an online form. Schools must utilize all the original allocation before requesting funds from the B.1.10 strategy. Changes to student count are done through the Grant Payment Portal.
 - A flyer for the Monthly Webcast was released on 3/1/2022 with the topics of discussion. An additional webcast was scheduled on 3/8/2022 at 1:30 p.m. (Central Standard Time).
 - FY2022 FAD Cycle One opened on 2/28/2022. There were some delays in receiving the reports. The issues were resolved and can continue to resubmit the FAD file. Cycle one does not require reconciliation, however, THECB encourages schools to review their data and budget totals to assist with future reconciliation process for cycle three. Schools are encouraged to to submit a FAD file in enough time to work through any errors.
 - State Financial Aid Opt-in/out released on 2/22/2022: All institutions are required to complete the Opt-in/Opt-Out form by 3/11/2022 to participate in the state financial aid programs:
 - Educational Aide Exemption (EAE)
 - Texas College Work-Study (TCWS)
 - Work-Study Student Mentorship (WSMP)

Institutions that do not submit an Opt-In/Opt-Out form by the deadline will not be included in the allocation calculation process for the 2023 Fiscal Year.





People Age 25 and Older Who Have Not Finished High School (2018)





Population Age 25 and Older with a Bachelor's Degree or Higher by Race/Ethnicity (2018)






Percentage of Texas High School Graduates Enrolling in College Immediately after Graduation


Percentage of Texas High School Graduates Enrolling in College Immediately after Graduation







Percentage of Texas High School Graduates Enrolling in College Immediately after Graduation















Texas Student Pipeline by Race/Ethnicity Transition Rates from 8th Grade to College Completion








Texas' Population Projections

Projected 2050 Population by Age and Ethnicity in Texas






Percentage of Texas Graduates with Student Loans, by Degree Level and Race/Ethnicity (FY 2020 Graduates)





Cumulative Borrowing in Texas


Median Loan Amount For Texas Graduates with Student Loans, by Degree Level and Race/Ethnicity (FY 2020 Graduates)







Consumer Debt Delinquency


Percent of U.S. Consumer Debt Balance That is 90+ Days Delinquent, Over Time, 2005-2021

Texas, National Three-year Cohort Default Rates* (FY 2011–2018)




Cohort Default Rates by Texas Region





Cohort Default Rates by Program Length








Defaults by Graduation Status

Percentage of Borrowers Who Defaulted within 12 Years of Starting College, by Degree Type, 1995-96 and 2003-04 Cohorts




Highest Completed Degree Type















Recent Studies of Food Security Amongst Community College Students Using the U.S. Department of Agriculture Scale




Housing Security and/or Homelessness within Prior Twelve Months at Community Colleges, from Trellis' Fall 2019 Survey


Costs at Texas Community Colleges





Net Price – Lower for Low-Income


Average Net Price for Full-time, First-time Undergraduates in Texas by Sector and Income Quintile (AY 2019-2020)




Texas Students Depend on Federal Aid

Update on Online TASFA

This topic will provide an update on the progress of the online TASFA, as well as the paper application.

Update Online TASFA:

- We are continuing to refine the Online TASFA and are progressing with our internal and external user acceptance testing.
- There is not a solid date for the release of the online TASFA.
- For 2023-24, we suspect that many students have already applied so the number of students may be small which will help with the refinement of the application.
- Working on a new portal system that will replace CBPASS to login into the application.
- Working on the signature page that will allow for touch screen or to draw their signature.
- There will be changes to the test file; currently THECB is doing internal testing of the test file
- Updating the file format into fixed length but will have a CSV version to view but not to import

Update on Paper TASFA

- New look and feel of the paper application
- New color scheme and branding
- o The flow was redesigned to align with the online TASFA once launched
- No additional elements but eight questions removed based on the recommendations from the TASFA Subcommittee.

- Aligned the language in the TASFA with the FAFSA
- Add a place for College Information and designate the housing status at the school.
- o Added the student ID at the end of the paper TASFA.
- Redesigned the TASFA NOTES section to align with the TASFA; much longer than before.

Committee Comments:

- What are the regulations for the schools to use the online TASFA?
 - The rules are written to where the schools must accept the data from the state application.
 - We will be working on guidance for those schools that continue to use their own TASFA.
 - All schools will be required to accept the data by Oct. 1, 2023.
- Can the file be printed into a TASFA Application
 - For the introductory go live, the functionality will not be ready before the Go Live.
 - There is a long-term plan to enhance capability to include an administrative portal.

Update on FAD Data Modernization

This topic will provide an update on the progress made on the modernization project and the user access testing (UAT).

Update:

- We are ready for beta testing for the data submission portal for cycle three. Information will be sent to six schools that tested previously.
- We will be beta testing 2023 FAD Cycle One in January with the goal of launching the new submission portal in February 2023.

Update:

- THECB is in the process of performing a soft launch of a newly redesigned website. The color scheme and the navigation from page to page is very different. We are still working on a few areas before we do a full launch.
- FORWARD Loan Program is schedule to launch on January 15, 2023. The
 Future Occupations & Reskilling Workforce Advancement to Reach Demand
 (FORWARD) Program provides alternative educational loans to Texas
 students who are unable to meet an institution's cost of attendance (COA).

Eligibility Requirements

- The student must:
 - Be classified by the institution as a Texas resident
 - Be registered with Selective Service, or be exempt
 - Meet the satisfactory academic progress requirements set by the institution
 - Receive a favorable credit evaluation or provide a cosigner who has good credit standing and meets other requirements
 - Be pursuing a High-Demand Credential
 - Eligibility for the program ends two years from the start of the semester in which the student received the first loan through the Program
 - Additional enrollment requirements:
- If enrolled in a degree program, must have completed at least 50% of the required coursework prior to receiving a loan through the Program.
- If enrolled in a non-degree program, the program's duration must be less than two years.
- If enrolled in master's degree coursework, the master's degree must be part
 of a combined baccalaureate-master's program approved by the institution
 of higher education.

o Loan Amounts:

- Annual: Cost of attendance less other financial aid and family resources
- Aggregate: Cannot exceed manageable student loan debt as determined by the Texas Higher Education Coordinating Board
- An origination fee will not be assessed for all approved FORWARD borrowers

o Interest Rate:

- Interest begins to accrue on the outstanding principal from the date of disbursement using simple interest.
- Loans are not eligible for interest subsidy, but the interest is not capitalized.
- Interest is currently a fixed annual rate of 2.00%.

Additional Information:

• Where can they learn more about this program? Rules have been written for the FORWARD loan program and are in public comment period. Once Rules are finalized and approved, they would be available to schools. Also, information such as Fact Sheet, Program Comparison Chart, and Program Guidelines will be program resources for schools.

More information can be found after rules are adopted: <u>Coordinating</u>
<u>Board Rules, Chapter 22, Subchapter C</u> and the <u>Texas Education Code</u>,
Chapter 52.

- What are the eligible high-demand credentials for the launch? Nursing/Patient Care, Teaching, Transportation/Logistics, Energy (223 separate CIP codes under these four disciplines)
- Are CIP codes specific to certain schools? How will schools know
 if they exist at their school? The CIP codes are not specific to certain
 schools.
- Who at the institution is responsible for confirming eligibility? Whoever currently certifies CAL loans would more than likely be responsible for confirming eligibility. However, we don't think we would stipulate who is responsible for confirming eligibility at the school. That should be a school decision.
- How will they be notified when a certification is ready? A CSV file will be uploaded to their folder in MoveIT.
- How do schools certify? School certification will occur in HelmNet.
- When will training be provided? TBD
- Will there be resources available to help navigate through the program (i.e., eligibility, loan management, returning funds, FADs, etc.) and when will those be released? Fact Sheet and Program Comparison Chart are currently in development. It is our understanding that FAS will be creating Program Guidelines for FORWARD. In addition, information will be on the various Agency websites. A soft launch of the program is scheduled for the Spring semester, a more robust launch later in the Spring for the Fall semester start.
- When will additional credentials be added? No set timeframe but assume new credentials will be added prior to the Fall 2023 semester. We would not anticipate new credentials mid-semester, but it could happen.

 - Yes, it will be starting in cycle 2 for 2023 FAD file submission. The data element will be sent within the FAD manual.

Discussion Topic: Changes to the Texas College Work-study (TCWS) and Work-study Student Mentorship Programs (WSMP)

This topic will discuss the changes to TCWS and WSMP programs that were adopted based on the Negotiated Rule-making Committee

Specifically, the amendment to CHPT 22G modifies the Texas College Work-Study Program allocation process based on the consensus reached by the negotiated rulemaking committee. The adopted amendments (in addition to revisions affecting 19 TAC §22.2 and §22.135) are necessary to implement the substantive changes upon which the Negotiated Rulemaking Committee on Texas College Work Study reached consensus (May 10, 2022).

Section 22.128 is amended to add the definition of forecasting to be used in the allocation methodology.

Section 22.133 is amended to alter the allocation methodology used for the Texas College Work-Study Program and the Work-Study Student Mentorship Program, beginning with Fiscal Year 2024. The consensus reached by the negotiated rulemaking committee includes combining the Texas College Work-Study Program and the Work-Study Student Mentorship Program allocations into one allocation methodology, using the average of three years of data when calculating allocations, providing allocations for each year of the biennium at the same time, providing additional weight in the methodology for students enrolled three-quarter-time, aligning the Expected Family Contribution used for allocation purposes with the federal Pell Grant program, and indicating how reductions in funding would be handled. Aspects of the allocation rule regarding reallocations and summer awards are removed, as they are no longer relevant.

Specifically, the amendment to CHPT 22A will modify subsections (1) through (3) to integrate the work-study disbursement process. Subsection (4) is removed, as it will be replaced by Texas Administrative Code, Title 19, Part 1, Chapter 22, Subchapter G, §22.135.

§22.2. Timely Distribution of Funds.

All institutions participating in the financial aid programs outlined in Chapter 22 shall follow the guidelines for the timely distribution of funds, as outlined in this section:

(1) Timely Disbursement. Institutions shall disburse state student financial aid funding to a student recipient's account or, in the case of work-study, through a paycheck, no later than three business days after receiving the funds. Undisbursed funds must be returned to the Board no later than six business days after the receipt of funds. Gift aid and work-study funds for which a student is no longer eligible may be disbursed to a different eligible student for whom funds have not yet been requested to meet the timely disbursement requirement.

Historically, funding for the state grant and loan programs has been disbursed to institutions on an as-needed basis, with expectations that it be disbursed to students in a timely manner and returned to the agency in a timely manner, if required. These expectations are outlined in Rule 22.2. The work-study program has operated under a different approach, with the agency disbursing the institution's entire allocation as a lump sum at the start of the fiscal year. Greater flexibility for institutional planning of work-study funding is being proposed for negotiated rulemaking, and the agency is implementing improvements to the technology supporting the financial aid disbursement request process. With these changes, it is also proposed that the work-study program align with the expectations made of other state and federal aid programs, which disburse funding to institutions on an as-needed basis and with the expectation of timely disbursement, to ensure the agency takes a fiscally prudent approach to these appropriations.

No comments were received regarding the adoption of these amendments.
