#### 60x30TX Data Insight: Discussion of COVID-19 impact on summer enrollment

**RECOMMENDATION:** No action required

#### Background Information:

This presentation focuses on preliminary enrollment data from summer 2020 which were requested from Texas public institutions of higher education to provide insight on possible impacts of the COVID-19 pandemic on postsecondary enrollments.

The data collection was structured much like the fall preliminary enrollments that are conducted every year by Texas Higher Education Coordinating Board staff and presented to the Board each October. As preliminary enrollment data for previous summers are not available, summer 2020 Census Date enrollments will be compared to certified data from prior summers to illustrate past trends and highlight any differences observed in the summer 2020 preliminary data.

#### Update on Data Infrastructure Modernization Project

**RECOMMENDATION:** No action required

#### Background Information:

Texas' rich collection of longitudinal data collection spanning K-12, higher education, and workforce represents an extraordinary asset for informing both policy and practice. Today, however, these data are not necessarily analyzed and presented as actionable intelligence in ways that support current decision-making or facilitate continuous improvement for institutions, the state, or students and families.

In addition, achieving the state's higher education goals requires Texas to educate more students from more diverse backgrounds than ever before. Linking existing data with data sets such as those from the National Student Clearinghouse, Census, and other researchers, and making the resulting analyses available to stakeholders, would allow critical questions to be more easily answered, such as:

- Which programs are best supporting Texas students to enroll, complete with a credential of value, and find meaningful employment?
- What factors predict on-time graduation from postsecondary education institutions and positive employment outcomes?
- What are the most common pathways for students into and through postsecondary education, and what supports are most important in strengthening those pathways?
- What are the earnings and employment outcomes of various credentials and degrees, and how aligned are those with the needs of Texas' economy?

The Texas Higher Education Coordinating Board is embarking on a planning effort to inform the design of a modern data infrastructure that facilitates this new approach to data use.

## AGENDA ITEM V-C

#### <u>Consideration of approving the Commissioner's recommendation to enter into a services</u> <u>contract for access to student out-of-state data</u>

#### **RECOMMENDATION:** Approval

#### Background Information:

The agency proposes to purchase Student Tracker Premium data services from the National Student Clearinghouse for 2020 and 2021. These data would be used to track the educational progress of students from Texas who enroll in higher education institutions in other states, including tracking persistence and completion. Adding student-level, out-of-state data to the agency's data resources would enhance the Texas Higher Education Coordinating Board's (THECB) ability to analyze and, therefore, better understand the student educational pipeline through analyses and studies, including informing the *60x30TX* higher education plan progress metrics.

Several other benefits would result from the purchase of Student Tracker Premium data services, including:

- The services would provide access to custom reports and visualizations of data as well as timely updates to both in- and out-of-state enrollment and completion data.
- Institutions of higher education in Texas that already purchase Student Tracker services from the Clearinghouse would have the ability to upgrade to Premium services, at no charge, for the full two-year period of the contract between the Clearinghouse and the THECB.
- The data would be used to identify out-of-state transfers from Texas community colleges for the purpose of Success Point funding.
- The contract would allow for providing de-identified data to the state's three Education Research Centers.
- In year two of the contract, data on public high school graduates would be available to assist the Texas Education Agency in tracking high school graduates who leave the state to pursue higher education.

The 86th Texas Legislature included funds "for access to out-of-state student data" in the 2019 budget under the agency's administrative funds. The appropriation covers both years of the biennium.

**RECOMMENDATION:** Approval

Background Information:

Texas A&M University-Corpus Christi requested approval for an Energy Savings Performance Contract with a total project cost of \$9,500,000 and a contract term of 20 years. This project meets all standards pertaining to Energy Savings Performance Contracts.

The Texas Higher Education Coordinating Board (THECB) has the authority to review capital development projects and improved real property purchases but does not have approval authority for those projects. The THECB is, however, responsible for approving Energy Savings Performance Contracts. Board rules delegate the approval authority for these contracts to either the Assistant Commissioner for Strategic Planning and Funding; the Committee on Innovation, Data, and Educational Analytics; or the full Board, based on the parameters specified in Chapter 17, Subchapter B, Section 17.12 of Board rules. Given the cost and the term of this project, the Committee on Innovation, Data, and Educational Analytics is the approval authority.

# **Project Description:**

Texas A&M University-Corpus Christi (TAMUCC) has engaged Ameresco, Inc. to conduct a 20year energy savings performance contract, which will provide for significant building and infrastructure improvements to 34 buildings. These improvements include upgrades to interior and exterior lighting, air conditioning, heating and ventilating systems, plumbing fixtures, and transformers that will allow the university to improve energy efficiency while maintaining a more comfortable environment for the building occupants.

The implementation of this project is projected to save electric consumption of 7,367,197 kwH per year, reduce electricity demand by 1,425 kwH per year, and reduce annual water and waste water consumption by 4,904 kGal per year. Based on a third-party engineer's review, the project's total design/construction cost has a projected first year utility savings of \$544,173 and escalating each year thereafter for a simple payback of 16.7 years.

In addition to deriving energy savings, these improvements will reduce future operation and maintenance expenses associated with the affected facilities. The implementation of these measures will result in reduced energy consumption, minimize campus carbon footprint, and enhance campus infrastructure reliability which will create a better environment for students, faculty, staff, and visitors.

The project was not listed on the institution's Capital Expenditure Plan, however, the institution reports that this was an unforeseen opportunity based on funding availability.

# Consideration of adopting the staff recommendation to the Committee relating to the report on the TEXAS Grant Program *(Texas Education Code, Section 56.311(c-1))*

**RECOMMENDATION:** Approval

Background Information:

The Texas Legislature established the Toward EXcellence, Access, and Success (TEXAS) Grant Program in 1999 (Texas Education Code, Section 56.301) to provide assistance to academically prepared high school graduates with financial need to pursue higher education.

Texas Education Code, Section 56.311(c-1) requires the Texas Higher Education Coordinating Board to provide by September 1 of each year a report regarding the operation of the TEXAS Grant Program to the governor, lieutenant governor, speaker of the House of Representatives, and the Senate Higher Education Committee members. The report regarding the operation of the TEXAS Grant Program, includes the following information from the three preceding state fiscal years:

- Allocations of TEXAS Grants by eligible institution, disaggregated by initial and subsequent grants.
- The number of TEXAS Grants offered to students, disaggregated by race, ethnicity, and expected family contribution.
- Disaggregated by race, ethnicity, and expected family contribution, and reported both on a statewide basis and for each eligible institution, the number of TEXAS Grants offered to students who meet:
  - only the eligibility criteria described by Section 56.304 (relating to Basic Eligibility requirements); or
  - the eligibility criteria described by Section 56.3041(2)(A) (relating to Priority Model requirements).
- The persistence, retention, and graduation rates of students receiving TEXAS Grants.

A draft of the TEXAS Grant report will be provided under separate cover.

<u>Consideration of adopting the Commissioner's recommendation to the Committee relating to</u> proposed amendments to Chapter 1, Subchapter A, Section 1.18 of Board rules, concerning the <u>Operation of Education Research Centers</u>

#### **RECOMMENDATION:** Approval

#### Background Information:

The Texas Higher Education Coordinating Board (THECB) proposes amendments to Title 19, Part 1, Chapter 1, Subchapter A, Section 1.18 Operation of Education Research Centers.

Specifically, this amendment will allow for improved access to data for education researchers while maintaining controls for data security. By law, up to three Education Research Centers (ERCs) are authorized to operate in Texas. The ERCs are under the oversight of the THECB and are governed by an Advisory Board which meets at least quarterly and includes representation from the Texas Education Agency, the Texas Workforce Commission, and each ERC, among others. Researcher proposals are reviewed and acted upon by the Advisory Board, and research must be of benefit to the state of Texas. The ERCs are self-funded.

Currently, researchers must access the P-16/Workforce Data Repository available through the ERCs by physically accessing special terminals at the ERC locations. The rule amendments would allow a researcher or researchers, when approved by the Advisory Board, to access the de-identified data approved for their project via remote access. Security guidelines for this access, including required Virtual Private Network (VPN) and multifactor authentication have been developed and approved by the ERC Advisory Board. All FERPA and other federal and state education privacy law requirements must be met, as stipulated by existing ERC law and rule.

There would be minimal costs to public institutions of higher education to adjust to the revised rules, given the security measures that the authorized ERCs already have in place and the self-supporting nature of the Education Research Centers.

- (a) Definitions. The following words and terms, when used in this section, shall have the following meanings, unless the context clearly indicates otherwise.
  - (1) (2) No change.
  - (3) P-20/Workforce Data Repository refers to the collection of data from each Cooperating Agency. The cooperating agencies shall execute agreements for the sharing of data for the purpose of facilitating the studies or evaluations at Education Research Centers (ERCs). In accordance with the agreements, each cooperating agency shall make available all appropriate data, including to the extent possible data collected by the cooperating agency for <u>at least</u> the preceding 20 years. A cooperating agency shall periodically update the data as additional data is collected, but not less than once each year. The repository shall be operated by the CB.
  - (4) (5) No change.

- (b) Purpose.
  - (1) ERCs shall be established by the CB. An ERC may only be established at a sponsoring public institution of higher education in Texas but may be awarded to a consortium of such institutions. An ERC must be physically located within Texas and must retain all data at that location except for secure off-site data back-up in accordance with written procedures approved by the Advisory Board. Individual level data from the ERC P-20/Workforce Data Repository may not be provided to a researcher except in the following ways:
    - (A) Individual level data may [not] be provided to a researcher at a [location other than a] Research Center or the CB or a public institution of higher education located in Texas that is an acknowledged consortium member of the ERC.
    - (B) Individual level data may be accessed by approved researchers via secure, restricted, VPN remote access provided all other provisions of this chapter are met and established policies are followed regarding additional controls.
  - (2) (3) No change.
  - (4) The ERCs may provide researchers access to shared data only through secure methods and require each researcher to execute an agreement regarding compliance with the Family Educational Rights and Privacy Act of 1974 (20 U.S.C. §1232g) and rules and regulations adopted under that Act. Each ERC shall adopt rules or policies to protect the confidentiality of information used or stored at the center in accordance with applicable state and federal law, including rules or policies establishing procedures to ensure that confidential information is not duplicated or removed from an Education Research <u>C[e]enter or from a remote access interface</u> in an unauthorized manner.

- (3) All research at an ERC involving access to confidential information shall be conducted with the approval of the Advisory Board or by request of the Texas Workforce Commission, Commissioner of Higher Education or the Commissioner of Education if the requesting agency provides sufficient funds to the ERC to finance the project. <u>All remote access</u> research at an ERC involving access to confidential information shall be conducted with the approval of the Advisory Board.
