### Background

As per statute enacted in 2017 by the 85th Texas Legislature, the Coordinating Board is required to provide a report to the Legislature that includes a summary compilation of data on the higher education and workforce outcomes of students who graduated from Texas public high schools based on the Individual Graduation Committee (IGC) review process allowable under the Texas Education Code, Section 28.0258. The summary data is due to the legislature no later than December 1 of even numbered years.

The report must include whether a student: (1) enters the workforce; (2) enrolls in an associate degree or certificate program at a public or private institution of higher education; (3) enrolls in a bachelor's degree program at a public or private institution of higher education; or (4) enlists in the armed forces of the United States or the Texas National Guard.

With the exception of data on military enlistments, which are not available to the Coordinating Board at this time, the required elements are included in this summary statistics report. The data show that 22.9% of IGC students who graduated from a Texas public high school in 2019 (3,377 of 14,761 IGC graduates) enrolled in higher education directly after high school, with a large majority of those students choosing to attend two-year public community, state, and technical colleges (3,035 students). Past trends are also provided, which show a gradual increase in higher education enrollments and workforce involvement for this population of graduates since the program began.
