

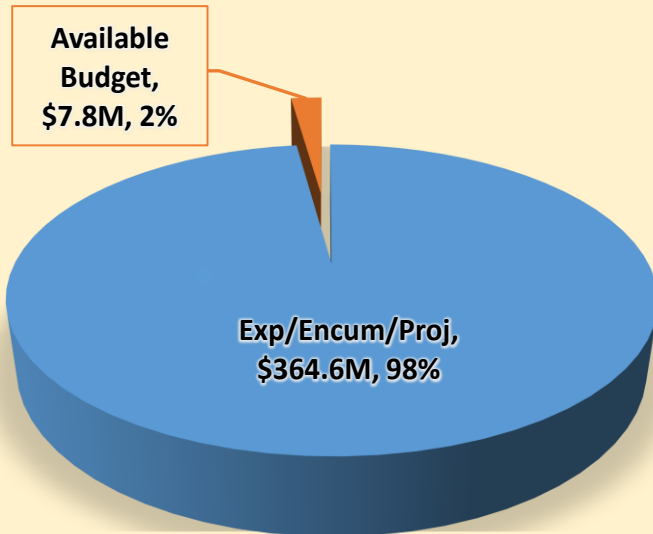

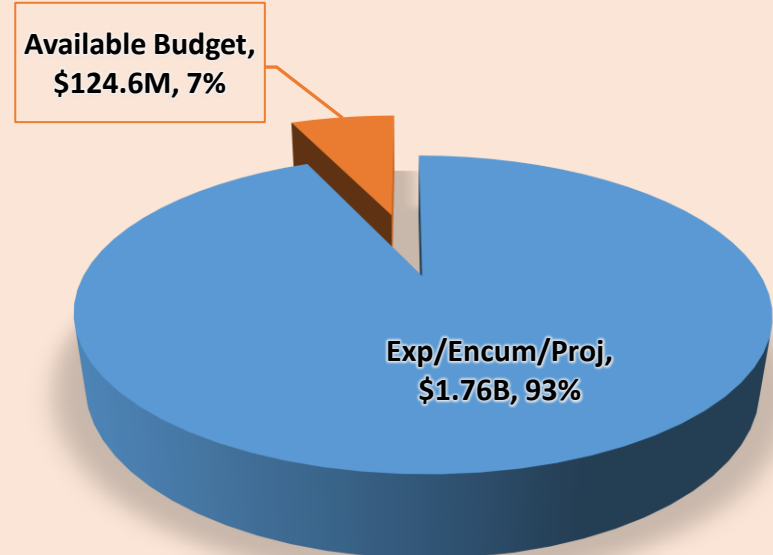

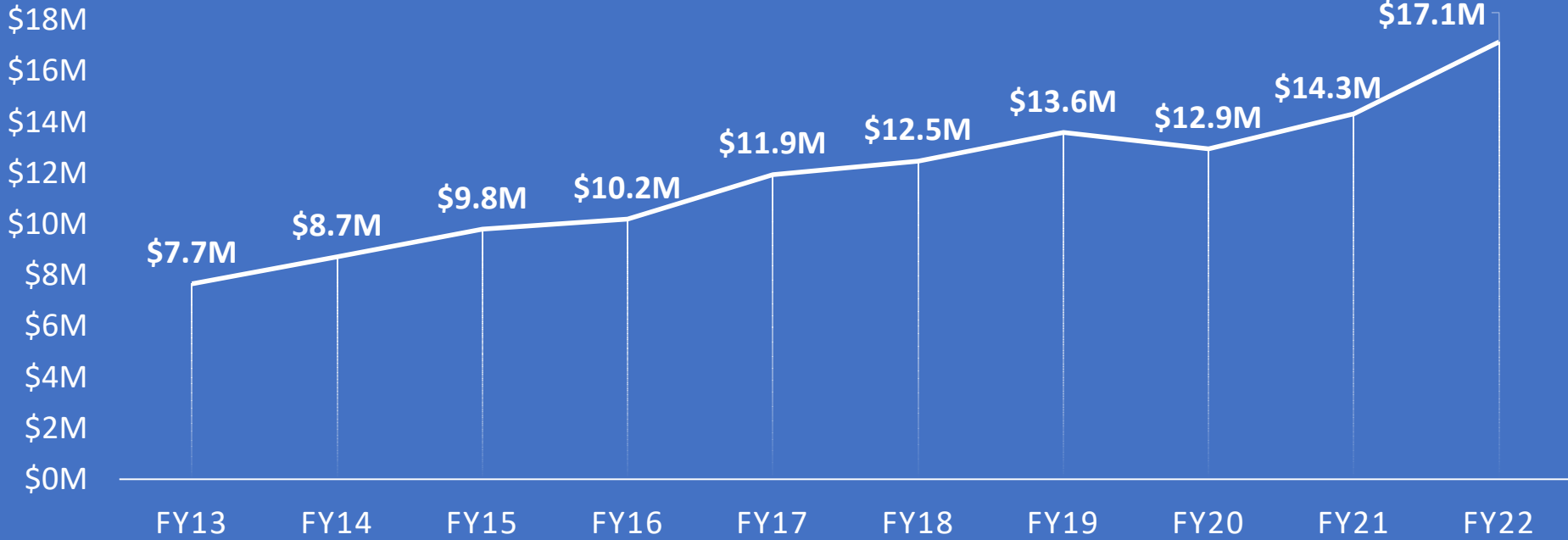
Loan Forecasting and Trending Period Ending: 5/31/2023
