The Austin Community College District Board of Trustees is comprised of nine members, all of whom live within the ACC taxing district. The members of the Board and their term expiration include:

The Austin Community College District (ACC) respectfully supports the \$1.83 billion formula funding request submitted by the Texas Association of Community Colleges (TACC) in its letter to the Legislative Budget Board and the Governor's Office, Budget Division. State support remains critical to the district as it continues to fulfil its statutory role and mission to offer vocational, technical, and academic courses for certification or associate degrees. Together with Texas' other 49 community college districts, we will continue do much of the heavy lifting in the state's efforts to achieve the 60X30TX plan. State support will further be necessary to help address costs related to mitigating the effects of the pandemic, including transitioning to distance education, providing for personal protective equipment, and safely delivering the required in-person instruction essential for students in healthcare and other technical/vocational programs.

In response to the economic downturn resulting from the COVID-19 pandemic, Texas community colleges began developing a workforce initiative aimed at providing low or no-cost short-term workforce training leading to high-demand credentials to Texans whose employment and/or academics had been recently disrupted. The Austin Community College District respectfully supports the \$50M exceptional item request submitted by TACC in support of this statewide workforce initiative, funded in the amount of \$1M per college district for the 2022-23 biennium.

Additionally, ACC requests continued current level funding for its two special item appropriations: Virtual College of Texas, and the TX Innovative Adult Career Ed Grant. Additionally, ACC requests an increase in the TX Innovative Adult Career Ed Grant.

State funding will enable Austin Community College District to address the specific postsecondary education and workforce training needs of its growing local community, including the goals of 60X30TX. Below are the investments to be supported from the state funds for our college district.

- ACCelerator expansion for accelerated completion of developmental education and competency based delivery of instruction
- expansion of Health Sciences Programs through development of a regional STEM simulation lab
- Creation of Workforce Innovation Center for expansion of industry needs in advanced manufacturing and robotics
- Expansion of Culinary arts and hospitality programs to meet needs of community
- Dual Credit, including Academies and Early College High Schools
- Curriculum Alignment between High Schools and ACC
- New Strategies in Teaching and Learning, including competency-based and project-based learning.
- Service Learning, Internships, and Apprenticeships
- Redesigning Learning Support Systems
- Supplemental Instruction
- Developmental Math redesign
- Case-management systems for holistic advising
- Guided Pathways and Development of "meta-majors" to align with HB Endorsements.

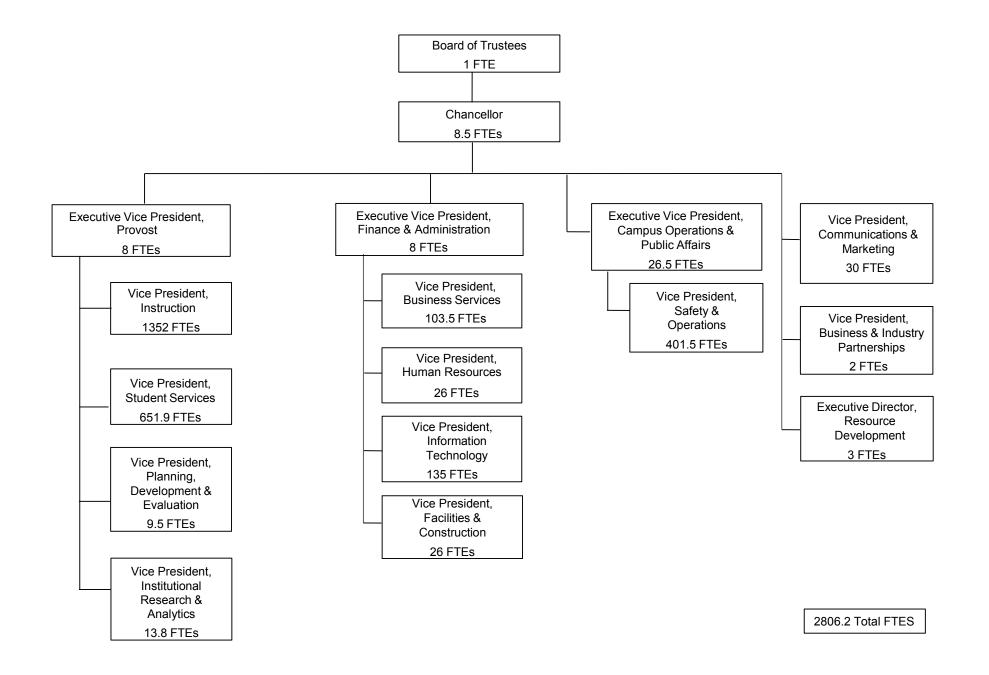

DESCRIPTION / JUSTIFICATION:

A 5% reduction in DigiTex's current budget -- \$43,890 during the biennium -- could result in one or more of the following potential negative impacts on our planned initiatives and services to support Texas public community colleges:

• We could be unable to subsidize participation in course sharing at our current level and would be unable to fulfill the planned level of growth. Currently we subsidize 15 colleges @ \$3,000 each per annum, as well as an additional rural college for \$1,500 annually, for a total of \$46,500.

• We could be unable to begin subsidizing official Quality Matters course reviews at member colleges, which provide evidence of meeting national standards for quality online learning. Each course review costs TxQMC members \$550; therefore, we would be unable to subsidize 80 course reviews.

• For the Open Texas 2021 conference, we have committed to providing sponsorship to cover partial conference costs up to \$5,000; additionally, we have agreed to continue to subsidize registration fees for 70 attendees from Texas community colleges for a total of \$6,000. We would be unable to continue this level of support for the two annual conferences during the biennium.

• For our third biannual statewide OER survey, scheduled to be conducted in FY 23, we could be unable to continue to partner with the Institute for the Study of Knowledge Management in Education, to whom we would need to pay an anticipated fee for services of \$23,000.

• We could be unable to hire a DigiTex Research Fellow, to assist in data analysis and collection, at an anticipated stipend of \$10,000/year.

This is an exciting time in DigiTex's 22-year history, one in which we are experiencing unprecedented growth and participation in initiatives that we offer. Restoration of the 5% budget reduction will ensure our ability to maximize state funds through collaboration to continue to support digital education at Texas community colleges at a time when they need it more than ever.

USE OF HOMELAND SECURITY FUNDS

There are two main types of COVID related expenses. The College has significant expenses in the form of student emergency aid, which was entirely funded by CARES HEER funds. These are identified as "Gants" in the Object of Expenses section of this report. The other major expenses category is equipment/technology. In order to support remote learning for 40,000 students and 5,000 employees, the College has procured over 1,000 notebook computers and 1,500 Ipads. Additionally, the College ahs had to acquire or expand several of software applications and IT infrastructure solutions for remote access. The College has been able to utilize the Institutional portion of the CARES HEER funds in order fund these expenditures. Of course, there have also been costs associated maintaining a safe physical environment, but these cost has have been relatively small given that we are primarily in a remote learning/working environment right now.

(2) Mission:

The Virtual College of Texas (VCT) is a consortium of accredited, public Texas community and technical colleges. It maximizes student access to higher education with its seamless model of delivering distance education. Enrolling at their local colleges, students are able to enroll in distance learning courses provided by other colleges throughout Texas. Student success is reinforced with support services delivered by the home colleges enrolling the students

(3) (a) Major Accomplishments to Date:

We continue to facilitate inter-institutional course sharing among Texas community colleges, helping students find courses unavailable on their campus that they need at the time in order to complete credentials, among other benefits. Harnessing the power of collaboration, course sharing can expand options for students, supporting progress, retention, and success, therefore helping to fulfill the goals of 60x30TX. Since January 2020, 16 colleges have participated, and since March, enrollments through DigiTex's course sharing consortium have increased nearly 150%. We particularly work to support rural college participation; in April, Forbes magazine featured this work in an article on innovation in online education.

In 2019, we partnered with the company Acadeum for more effective and efficient course sharing in Texas (and potentially beyond). Acadeum's Academic Sharing Platform facilitates enrollment and payment processes and provides additional student support.

Between March and July 2020, over 900 faculty received QM training at TxQMC member institutions, twice the number of faculty trained in the previous year for that same period.

(3) (b) Major Accomplishments Expected During the Next 2 Years:

Open Texas 2021 conference, we have committed to providing sponsorship to cover partial conference costs up to \$5,000; This year, we have released Digital Higher Education in Texas: A Meta-Analysis of Data and Research in order to assess the gaps in that information and determine how we might impactfully contribute to the body of knowledge in this area. This paper examines existing sources of data and research focused on Texas, suggesting which categories may be missing from the body of state data and research, and suggests directions for future research in order to gain a more comprehensive picture of the state of digital higher education in Texas. We have begun research on the state of digital education at Texas community colleges, including impacts of the COVID-19 crisis.

Finally, we plan to create a DigiTex Research Fellowship in order to support our work in the area of data collection and analysis, and to assist in the professional development of researchers with expertise in Texas digital higher education.

• We could be unable to subsidize participation in course sharing at our current level and would be unable to fulfill the planned level of growth. Currently we subsidize 15 colleges @ \$3,000 each per annum, as well as an additional rural college for \$1,500 annually, for a total of \$46,500.

• We could be unable to begin subsidizing official Quality Matters course reviews at member colleges, which provide evidence of meeting national standards for quality online learning. Each course review costs TxQMC members \$550; therefore, we would be unable to subsidize 80 course reviews.

• For the Open Texas 2021 conference, we have committed to providing sponsorship to cover partial conference costs up to \$5,000; additionally, we have agreed to continue to subsidize registration fees for 70 attendees from Texas community colleges for a total of \$6,000. We would be unable to continue this level of support for the two annual conferences during the biennium.

• For our third biannual statewide OER survey, scheduled to be conducted in FY 23, we could be unable to continue to partner with the Institute for the Study of Knowledge Management in Education, to whom we would need to pay an anticipated fee for services of \$23,000.

• We could be unable to hire a DigiTex Research Fellow, to assist in data analysis and collection, at an anticipated stipend of \$10,000/year.
