### **Executive Summary**

Per Texas Education Code (TEC), Section 28.02591, enacted in 2017 by the 85th Texas Legislature, the Texas Higher Education Coordinating Board (Coordinating Board) is required to provide a report to the Legislature that includes a summary compilation of data on the higher education and workforce outcomes of students who graduated from Texas public high schools based on the individual graduation committee (IGC) review process allowable under the TEC, Section 28.0258. The summary data is due to the Legislature no later than December 1 of even-numbered years.

The report must include whether students: (1) entered the workforce; (2) enrolled in an associate degree or certificate program at a public or private institution of higher education; (3) enrolled in a bachelor's degree program at a public or private institution of higher education; or (4) enlisted in the armed forces of the United States or the Texas National Guard.

With the exception of data on military enlistments, which are not available to the Coordinating Board, the required elements are included in this summary statistics report. The data show that 17.1% of IGC students who graduated from a Texas public high school in 2021 (the most recent graduation data as of September 2022) enrolled in higher education directly after high school (2,634 of 15,415 IGC graduates), with a large majority of those students choosing to attend two-year public community, state, and technical colleges (2,106 students).




Figure 1. Summary of Higher Education Enrollment and Workforce Participation for IGC Graduates, 2017-2021

Past trends are also provided, which show a gradual increase in higher education enrollments and workforce involvement for this population of graduates since the program began. However, there was an increase in IGC students not found in higher education or the workforce in Texas in 2020, which correlates with similar statewide trends due to the COVID-19 pandemic (see Figure 1).

## Outcomes for Individual Graduation Committee (IGC) High School Graduates

Tables 1-5 show postsecondary enrollments and outcomes for each cohort, Fiscal Year (FYs) 2017-2021. All cohorts are tracked through FY 2021 (the most recent graduation data as of September 2022). Each cohort is tracked a different number of years for graduation outcomes. For example, FY 2017 is tracked for five years, and FY 2020 is tracked for one year.
