### **Speakers**

#### **Eric Algoe**

Eric Algoe has served as the Vice President for Finance and Support Services at Texas State University since 2015, where he oversees the financial, physical, safety, and human resources of the university.

Algoe formerly served as Associate Vice President for Finance and Administration at Florida State University and as Vice President for Finance and Administration at Ohio Wesleyan University. He left a positive mark during his terms in leadership at one of the top public research universities in the world and one of the nation's premier private universities.

His career has focused on public service and mission-driven nonprofits, including past experience as the Chief Fiscal Officer at the Ohio Schools for the Deaf and the Blind, the inaugural chief fiscal officer for the Ohio Office of Information Technology, and 14 years of service as a military intelligence and civil affairs officer in the United States Army and Army Reserve.

Algoe holds a master's degree in business administration from Franklin University, and a bachelor's degree from The Ohio State University, where he later earned the Certified Public Manager designation at The John Glenn School of Public Affairs. He also currently serves as the president of the Texas Association of State Senior College and University Business Officers.

He is an engaged citizen in the community, having served on numerous community boards, committees, and task forces with organizations such as the Austin Chamber of Commerce and the United Way, as well as serving on the executive board of professional associations.

#### Pamela Anglin, Ed.D.

Dr. Pamela Anglin has served as President of Paris Junior College (PJC) since 2003. She is a Certified Public Accountant, and before becoming president of PJC, she served as Chief Financial Officer and Executive Vice President of Grayson College, Vice President of Business Services at Blinn College, was part of the accounting faculty and Division Director at Navarro College, and Director of Managerial Finance at Texas Christian University.

Anglin has served two terms on the American Association of Community Colleges (AACC) Board of Directors and two terms on the Southern Association of Colleges and Schools Board of Trustees. She chaired the Community and Technical College Formula Funding Advisory Committee in 2019-2020. Anglin's tenure at PJC has included the college participating in Achieving the Dream, being recognized twice as one of the 50 fastest-growing community colleges in the nation, and the college being recognized with the 2012 Excellence in Education Award from the Texas Association of Businesses. PJC was selected as one of 30 community colleges nationwide to participate in the AACC Guides Pathways Project in 2016.

Anglin's education includes an Ed.D. in education administration from Baylor University, an MBA in accounting from Texas Christian University, a BBA in finance from Texas A&M University, an ABA from Grayson County College, and she attended Harvard University's Institute for Education Management.

#### The Honorable Greg Bonnen, M.D.

The Honorable Greg Bonnen, M.D., is currently serving his fifth term as the state representative for House District 24 and is the chair of the House Appropriations Committee.

Before serving as chair of the House Appropriations Committee, he served as chair of the Appropriations Subcommittee on Higher and Public Education and as a member of the Insurance Committee. He has also previously served on the Energy Resources Committee; Appropriations Subcommittee on Health and Human Services; Appropriations Subcommittee on General Government, the Judiciary, and Criminal Justice; Joint Interim Committee on Coastal Barrier Systems; Texas Windstorm Insurance Association Funding Structure Oversight Board; Interim Committee on Border Security; and Interim Committee on Mental Health.

Bonnen has been named a Courageous Conservative by the Texas Conservative Coalition, Guardian of Small Business by the National Federation of Independent Business, Texas Values Faith and Family Champion, and Pro-Life Hero.

Bonnen is a practicing neurosurgeon and serves as the Chairman of the Board of Houston Physicians' Hospital.

Bonnen graduated cum laude from Texas A&M University with a Bachelor of Science degree in biochemistry, and attended medical school at UTMB, where he also did his neurosurgery residency and served for two years as an assistant professor of neurosurgery. During college, he spent two summers working as a counselor at Texas Lion's Camp for handicapped children, which he credits with introducing him to both his profession as a doctor and his wife, Kim. He continues to devote time to his church and charitable organizations, including numerous international mission trips.

#### **Kristin Boyer**

Kristin Boyer leads Trellis Foundation's efforts to advance equitable postsecondary outcomes for students in Texas. Before her appointment as Executive Director for the Trellis Foundation, she directed the philanthropic program and activities for Trellis Company, informed by her early career as a public school teacher, admissions counselor, and development officer in higher education. She currently serves as chair of the Leadership Committee for Philanthropy Advocates, as an Advisory Committee member for the Pell Institute for the Study of Opportunity in Higher Education, and as a co-chair for the Latino Student Success Funders Group.

#### Laura Brennan

Laura Brennan is the Assistant Commissioner for College and Career Advising at the Texas Higher Education Coordinating Board (THECB). She leads the development and implementation of a holistic and equitable college and career advising strategy for the state. Key initiatives within this work include My Texas Future, Texas OnCourse, ApplyTexas, Advise TX, and ADVi. Before joining the THECB, Brennan served as Director for Texas OnCourse, a college and career advising initiative that currently serves over 18,000 educators across the state. She completed her master's degree in education policy from The Harvard Graduate School of Education, where her research focused on access and success in higher education for traditionally underserved students. Earlier in her career, she worked at KIPP Austin Public Schools designing and implementing programming to support students to and through college.

#### Nichole Bunker-Henderson, J.D.

Nichole Bunker-Henderson, J.D., serves as General Counsel for the Texas Higher Education Coordinating Board (THECB). Before joining THECB, she served the Office of the Attorney General for 15 years, rising from law clerk to Chief of the Administrative Law Division, and most recently the Associate Deputy Attorney General for Civil Litigation. Henderson has worked on diverse matters as a trial and appellate attorney and general counsel to state agencies. She is a frequent speaker on administrative law topics. During her 20 years of government service, she has also served as the Deputy General Counsel at the Texas Education Agency and worked for the Texas Senate and Texas Legislative Council. She earned a bachelor's degree in government from The University of Texas at Austin and a law degree from The University of Arizona.

#### Amanda Cochran-McCall, J.D.

Amanda Cochran-McCall, J.D., serves as the Deputy Vice President for Legal Affairs at The University of Texas at Austin. In this role, she serves the institution as in-house counsel, guiding its course on a broad array of legal issues including constitutional, civil rights, employment, athletics, business contracts, real estate, and litigation strategy. McCall collaborates daily with university leadership in the executive administration, colleges, schools, and business units to support their needs and goals. By identifying legal issues and risk, providing a thorough analysis of options, and recommending solutions on the issues at hand, she works to support the university's goal to be the world's highest-impact public research university. She also leads the day-to-day operations of the university's Legal Affairs team.

Before joining the university, McCall served in various roles over almost a decade at the Texas Attorney General's Office. She managed and directed 12 civil litigation divisions of over 600 employees, 30,000 active litigation matters, and a \$40 million budget. She also provided strategic legal guidance and direction on various matters, including First Amendment, due process, equal protection, Title IX, employment law, and higher education issues for university systems and component institutions, state elected and appointed officials, and state agencies. As a trial attorney, she directed and performed all aspects of litigation in state and federal court.

McCall is a graduate of The University of Texas at Austin and Oklahoma City University School of Law.

#### **Matthew Crommett**

As Director at LH Capital, Inc. and Lyda Hill Philanthropies, Matthew Crommett oversees a portfolio of nature and science investments and grants for entrepreneurs and Lyda Hill. In this role, Crommett leads non- and for-profit efforts to protect and conserve nature through innovative opportunities that address land, water, and wildlife challenges, prevent and treat diseases through basic science discoveries and public health interventions, inspire girls to consider STEM (science, technology, engineering, and math) careers through the IF/THEN initiative, and grow a biotechnology ecosystem in North Texas.

Before this role, Crommett served as Deputy Director of Policy and Programs at the George W. Bush Institute, where he worked on issues spanning global health, economic growth, and veteran wellness. Before joining the Bush Institute, Crommett worked in the Executive Office at Goldman Sachs in New York, leading monitoring and evaluation for the \$100 million 10,000 Women initiative, which invests in underserved women entrepreneurs in more than 20 countries.

Crommett received a Bachelor of Science in international health from Georgetown University and a Master of Health Science in international health, with a concentration in social and behavioral interventions, from Johns Hopkins Bloomberg School of Public Health. He sits on advisory boards for the Water Foundation's Water Table and Georgetown University's School of Health.

#### **Bryan Daniel**

Bryan Daniel serves as Chairman and Commissioner of the Texas Workforce Commission (TWC), where he works to promote and support the growth of Texas' world-class employers and talented workforce. To champion that goal, he advances innovative workforce and economic development strategies in collaboration with TWC's education partners, local officials, and industry leaders to establish Texas' competitive edge as the best place to work

in the world.

Before joining TWC, Daniel served for four and half years on Texas Governor Greg Abbott's senior staff, where he led the Office of Economic Development and Tourism, which included the Texas Enterprise Fund, Events Trust Fund, Governor's University Research Initiative, Texas Tourism Office, Texas Music Office, Texas Film Commission, Texas Workforce Investment Council, the Economic Development Bank, the Texas Military Preparedness Commission, and the State of Texas Mexico Office.

Daniel's tenure as the Texas State Director for Rural Development for President George W. Bush and as Chief Administrator for Trade and Business Development at the Texas Department of Agriculture, along with his private sector experiences as a marketing executive and member of the board of directors, have provided him with valuable insights on economic development and workforce issues.

Daniel is a graduate of Texas Tech University, with both a bachelor's degree and master's degree. In 2019, Texas Tech's College of Agricultural Sciences and Natural Resources recognized Daniel as a Distinguished Alumnus.

#### Joseph Duron

Joseph Duron is the Chief Administrative Officer for the Texas A&M University System Offices. After graduating from Texas A&M University in 1992, Joseph began his career with the university as a staff accountant. In 1995, he left the university to join the Texas A&M University System Offices. There he began serving as a financial analyst for the Texas A&M System Budget Office.

As Chief Administrative Officer, Joseph is responsible for directing the overall Texas A&M System and System Offices budget and planning, coordination, and review. He is responsible for the oversight of the general comptrollership, which includes financial accounting and financial reporting. He also directs the production, review, and timely submission of various agenda items, management reports, and ad-hoc analyses that are provided to the Board of Regents, System Offices executive management, and member institutions and agencies.

Duron provides oversight of Human Resources, Procurement/HUB, Benefits Administration, centralized bookkeeping, and aircraft operations for the System Offices. He also assists the Governmental Relations Office and executive management regarding legislative issues, such as formula funding, statutory requirements related to tuition and fees, bill analysis, fiscal notes, and appropriation analysis. Most recently, he was appointed to serve on the Texas Higher Education Coordinating Board's General Academic Formula Advisory Committee as a representative for Texas A&M University and the Research Universities accountability group. Duron has degrees in accounting and finance from Texas A&M University and is a Certified Public Accountant.

#### Joe Elabd, Ph.D.

Dr. Joe Elabd is the Vice Chancellor for Research at The Texas A&M University System, a system of 11 universities and eight state agencies with externally funded research expenditures exceeding \$1 billion annually. As the leader of the Texas A&M System Office of Research, Elabd is responsible for providing leadership and services to support all 19 system members in areas including intellectual property and commercialization, research compliance, research development, research partnerships, research security, and research strategy.

Elabd is also a professor and the Axalta Coating Systems Chair II in the Artie McFerrin Department of Chemical Engineering at Texas A&M University. He is a Fellow of the American Physical Society and served as a Senior Fellow at the Instituto di Studi Avanzati, Università di Bologna, and a Scholar in Residence at the Food and Drug Administration. He has received numerous research awards including the NSF CAREER Award, DuPont Science and Engineering Award, and the ARO Young Investigator Award. His research focuses on electrochemical energy (batteries, capacitors, fuel cells) and materials and polymer science, and he has authored over 130 research journal publications. Elabd has taught chemical engineering courses at all levels (freshmen, sophomore, junior, senior, and graduate).

Elabd received his Ph.D. and B.S., both in chemical engineering, from Johns Hopkins University and University of Maryland, Baltimore County, respectively, and was a National Research Council Postdoctoral Fellow at the U.S. Army Research Laboratory.

#### Fred Farias III, OD, MCSO

Fred Farias III, OD, MCSO, is President and CEO of 20/20 Vision Care, the chair of the Texas Higher Education Coordinating Board, and a member of the Texas Higher Education Foundation.

He is a fellow of the American Academy of Optometry, former president of the Texas Optometric Association and the Rio Grande Valley Optometric Society, and a former member of the American Optometric Association Board of Trustees. He was the Texas Optometric Association's Optometrist of the Year in 2015 and the National American Optometric Association's Optometrist of the Year in 2016.

Farias served on the Texas Optometry Board and is a charter member of Optometry Cares - The AOA Foundation, a lifetime member of The University of Texas (UT) System Chancellor's Executive Committee and the UT-Austin Development Board, and a member of the UT Longhorn Foundation Athletic Advisory Council. He received the Outstanding Young Texas Exes Award from UT-Austin and, in 2017, received the Lifetime Achievement Distinguished Alumnus Award from the Southern College of Optometry. In 2019, he was named an Outstanding Alumnus by UT-Austin's Moody College of Communication.

Farias has served several community organizations, including the McAllen Chamber of Commerce Government Affairs Council; InfantSEE, a no-cost program to provide eye care to infants nationwide; the Vannie E. Cook Cancer Center; the Rio Grande Valley Arthritis Foundation; and the Museum of South Texas History.

Farias has a Bachelor of Science from The University of Texas at Austin, a master's degree from Harvard Medical School, and a Doctor of Optometry from Southern College of Optometry.

#### Vanessa Garcia

Vanessa Garcia is the Academic Advising Coordinator of the Vick Advising Excellence Center at the University of Texas at Austin (UT-Austin), where she works to support exploratory students, students completing developmental education, and assists to help bridge inequities in advising training across campus.

Garcia started at UT-Austin in 2017 as an Associate Academic Advisor in the School of Undergraduate Studies. Before starting at UT-Austin, she was an academic coach at Texas State University, where she worked to support students through their first year in college. Additionally, she interned at Texas Lutheran University assisting with career counseling and Texas State University working with NCAA compliance.

Garcia believes that empathy plays a major part in academic advising and student-support services. She enjoys building rapport with her students to better understand their specific challenges and struggles while being as resourceful as possible. She is mindful of the importance of holistic growth of college students and wants them to feel fully supported throughout their college endeavors. Garcia strives to develop an environment that is open and inclusive to all students on campus. As the Academic Advising Coordinator of the Vick Advising Excellence Center, her goal is to provide the necessary tools for all advisors on campus to support students to the best of their abilities.

#### **Garrett Groves**

Garrett Groves is Vice Chancellor of Strategic Initiatives for the Austin Community College (ACC) District. He joined the college in February 2018 and leads the college's efforts to identify emerging needs, evaluate opportunities for collaboration, and build strategic partnerships.

Before joining ACC, Groves directed the Economic Opportunity Program at the Center for Public Policy Priorities and served as a scholar-in-residence at the Federal Reserve Bank of Dallas, analyzing workforce practices and consumer credit conditions in the state. He has also served at the National Governors Association and the U.S. Department of Labor.

Groves has a master's degree from the LBJ School of Public Affairs at the University of Texas at Austin, a bachelor's degree from the University of Denver, and is expecting to complete his Doctorate in Higher Education Leadership at the University of Texas at Austin in 2023.

#### **Jeff Handy**

Jeff Handy is the Director of the Vick Advising Excellence Center at The University of Texas at Austin (UT-Austin), where he and his team aim to support academic advisors across campus by providing training, tools, and resources to empower advisors to deliver the highest levels of support to their students. He and the Vick Center team also advise students across campus who are looking for help exploring and changing majors.

Handy started at UT-Austin in 2015 as an Academic Advisor in the School of Undergraduate Studies and before that was an AmeriCorps member at the nonprofit College Forward, where he helped low-income and first-generation students earn a college degree.

Handy strives to support students in making informed decisions about their academic and career goals, and he believes excellent advising – made possible by well-trained advisors and purposeful tools and technologies – is one of the most effective resources we have to help every student feel empowered to navigate through and flourish from their experience in higher education.

#### Brenda Hellyer, Ph.D.

In 2009, Dr. Brenda Hellyer was appointed Chancellor of San Jacinto College, Texas' eighth-largest community college, with about 45,000 credit and noncredit students, five campuses, and several extension centers. The college opened its fifth campus at Generation Park in fall 2020. Before joining San Jacinto College, Hellyer worked in the corporate world as an accountant in both the private and public arena. She holds a Bachelor of Science in accounting from Fort Hays State University in Hays, Kansas, a master's degree in business administration from the University of Texas at Austin, and a doctoral degree in community college leadership from the University of Texas at Austin. Hellyer is involved with various commissions, committees, and boards at the national, state, and local levels.

#### Jim Henson, Ph.D.

Jim Henson, Ph.D., teaches in the Department of Government at the University of Texas at Austin, where he is the founder and Executive Director of the Texas Politics Project. The Texas Politics Project is a hub of research and public affairs work focused on providing nonpartisan resources for understanding Texas government and politics. As part of that work, in 2008, with Daron Shaw, he cofounded the longest running academic survey of public opinion in Texas; their latest work, released just a few weeks ago, was the 51st in that series of public polls.

Henson's writing about Texas politics has appeared in every major Texas media outlet, as well as a variety of publications, including *The Washington Post*, *The Hill, Texas Monthly, The Texas Tribune*, and others. He is the principal author of the *Texas Politics* textbook, published by Soomo Learning and used in introductory Texas government courses across the state, which is now in its 10th edition. He is a frequent resource for news media, researchers, and civic and interest groups.

#### Nelly R. Herrera, J.D.

Nelly R. Herrera, J.D., is the General Counsel for the Texas State University System (TSUS). She has been with the TSUS Office of General Counsel since July 2011. She is a magna cum laude graduate of St. Mary's University in San Antonio and received her Juris Doctor degree from the University of Texas School of Law.

From September 2018 to August 2021, Webber was based in Paris, France, where he served as the Chief Science and Technology Officer at ENGIE, a global energy and infrastructure services company. Webber's expertise spans research and education at the convergence of engineering, policy, and commercialization on topics related to innovation, energy, and the environment. His book *Power Trip: The Story of Energy* was published in 2019 by Basic Books with an award-winning six-part companion series that aired on PBS, Amazon Prime, and iTunes, starting Earth Day 2020. He was selected as a Fellow of the American Society of Mechanical Engineers and as a member of the 4th class of the Presidential Leadership Scholars, a leadership training program organized by former presidents George W.
